Sachchidananda - An Analytical Study

Sachchidananda and Sachchidananda. This single term is the compound form of three Sanskrit words namely sat, chit and ananda ; which describe the real nature of the Divine. Sachchidananda or sat-chit-ananda expresses the wholeness and oneness of all existences. Sachchidananda, this, is not a name but a state of being which refers to an organic unity of truth, awareness and bliss. Sat refers to eternal existence. It alludes to the basic substance of all that exists. The principle of existence is absolute which is beyond the concepts of time and space. Being beyond the concepts of time and space, it does not depend upon anyone's cognition. As the sat is the core of all existences, it can never be destroyed. It is what always remains. It simply dwells everywhere. Sat, thus depicts a truth which is infinite and everlasting. It is the fundamental reality of all beings. Chit means consciousness. It signifies awareness, comprehension and knowledge. In spiritual terms, it is the soul ; and in material terms, it is the

intelligence, thought and the ego. It is the principle of consciousness which bestows the ability to be aware of reality. It makes possible the perception of different objects and beings.
