sha Ambani means business. Not only when she is doing business — she leads Reliance Retail — but also when she is not. The latter was unmistakable on Wednesday, during her eight-minute 49second video address on the occasion of in Information Communications Technology (ICT) Day India 2024"

The Girls in ICT Day is hosted by the Department of Telecommunications, Government of India, the International Telecommunications Union (South Asia). the Innovation Centre, Delhi, and other agencies of the United Nations.

In the address, Ambani, who, along with her two brothers, is at the core of Reliance Industries' next generation of leaders and is a non-executive director on its board, exhorted young women to opt for STEM - science, technology, engineering and mathematics — and opt for technology as a career.

"A male-dominated STEM/ICT landscape, where women are under-represented, will rob India of its opportunity to rule the roost," Ambani said.

Kavil Ramachandran, who is with the Thomas Schmidheiny Centre for Family Enterprise, Indian School of Business, says

this is a good beginning. "We hope this is a new phase for Isha Ambani. We hope there will be many more. We need industry leaders to be influencers," he says.

Listening to Ambani, one is book that told women to embrace their ambitions and went on to spawn a movement.

"We must rise to the occasion, we must exert ourselves, and we must excel. Otherwise, we run the risk of becoming irrelevant," Ambani said. She also said: "So, by denying leadership roles to women, we

## '86% executives using AI to boost revenue'

SHIVANI SHINDE Mumbai, 15 May

As many as 86 per cent of senior business executives have deployed artificial intelligence (AI) to enhance revenue streams or create new ones, said a report by Tata Consultancy Services (TCS) on Wednesday.

As many as 69 per cent of businesses are more focused on using AI for innovation and increasing revenue than on improving productivity and optimising cost, said the 'TCS AI for Business Study'.

Executives are positive about the impact of AI, with 57 per cent reporting "excitement" or "optimism". As many as 45 per cent of respondents in the study

expected up to half the staffers will need to use GenAI tools to do their job in three vears' time and another 41 per cent think even a greater number will do so, 65 per cent believe AI will improve capabilities, enabling people to focus on activities that require creativity and strategic thinking.

"2023 was a year of exuberance, with every enterprise experimenting with AI/GenAI use cases. We are now entering an era of wide-and-deep enterprise AI adoption. Enterprises, however, are realising that the path to production for AI solutions is not easy, and that building an AI-mature enterprise is a marathon, not a sprint," said Harrick Vin, chief technology officer at TCS.

# 2nd bow arch girder joining Coastal Rd, sea link launched

Weighing 2,500 metric tonnes and measuring 143 metres in length, the second bow arch string girder connecting the Coastal Road and the Bandra-Worli Sea link was successfully launched in the early hours of Wednesday. Completing the arduous task was a race against time as the launch had to be undertaken within a three-hour window, given the tidal conditions in the sea. "Once completed, this will be India's longest arch bridge passing over sea," said a senior civic official.

The launch was postponed to Tuesday morning due to unfavourable climatic conditions the day before. On Wednesday around 3am, the civic officials, engineers and workers started setting up the **31.7** metres Width

girder again. "While setting up the first girder, engineers had the flexibility and ample space needed for a smooth setup process. However, launching the second girder posed a significant challenge due to limited space. Positioning the second girder just 2.8 metres away from the first one was a complex task," said a senior civic official. Keeping an eye

on the tidal conditions, the heavy-duty structure was moved in stages towards the first girder. The mission was successfully completed at 6.07am after ensuring the mating cones on all sides were perfectly matched, the official added.

In the next step, both the girders will undergo cement concretisation. Also, to prevent rusting, the BMC will be using the tried and tested C-5 system, a Japanese technology. The second girder is relatively larger and wider than the first one. It measures 31.7 metres in width and 31 metres in height. The pre-fabricated parts making up the girder were manufactured at Ambala, Haryana. It was hauled to the Worli site from the Mazagaon Dock on a barge, which reached on Ma

### **BMC** seeks stability certs of hoardings from rly, port trust

The BMC has asked the railways and the Mumbai Port Trust (MPT) to submit structural stability certificates of hoardings on their land within seven days. While the railways have 45 hoardings, MPT has 12. In its own jurisdiction, the civic team has found 30 hoardings without stability certificates. It is mandatory for billboard owners to take a from structural engineer every two years.

As per civic records, there are 1,025 authorised hoardings across the city from which the civic body earns a revenue of Rs100 crore through licensing fee. The owners have to obtain NOCs from the building proposal and soil testing departments and the tree authority. Thereafter, the process involves a one-year agreement with the advertiser and a fixed deposit and rental fee.

Considering the safety measures, the BMC never permits any hoarding above 40 X 40 feet but many larger hoardings exist. A senior civic official said, "There should also be a minimum gap of 70mt between hoardings, which is also not met in some cases. The companies also fail to submit a mandatory structural stability report." He added that the Western and the Ceptal Railways,

The official said, "We will not renew the license of owners of 30 billboards who have not submitted structural stability certificates. Without the certificates, their hoardings will be pulled down."

Civic chief Bhushan Gagrani said, "We have directed the railways and MPT to submit structural stability certificates of hoardings on their land. If they fail to do so in the next seven days, we are exploring the options of how we can take action under the Disaster Management Act 2005. We will also discuss the issue with the state government. However, we are confident that these authorities will cooperate with us.'

# Police struggle to catch owner of ill-fated hoarding

The cops went all the way to Lonavala, where Bhavesh Bhinde owns a posh resort; however, they didn't find him

Despite pulling out all stops to nab Bhavesh Prabhudas Bhinde, owner of Ego Media Pvt Ltd whose killer hoarding claimed 14 lives, the Mumbai police is yet to taste success. In his search, the cops also went all the way to Lonavala, where the 51-year-old businessman owns a posh resort, but didn't get him. Bhinde, who recently joined the Shiv Sena (UBT), is believed to be well-networked with the bureaucracy which helped him expand his hoarding busi-

The illegal massive hoarding fell on the BPCL's petrol outlet on the Eastern Express Highway, Ghatkopar (E), on Monday resulting in several persons being crushed, while leaving many seriously injured. After the crash, the Pant Nagar police registered a case against Bhinde following the BMC's complaint on Monday. Next day, police teams were sent to his office and home locations - both in Mulund - but were greeted with locked doors. On Tuesday night later, the Crime Branch joined the Pant Nagar police investigating team.

"Bhinde has three mobile numbers which we were constantly tracing; of three, only one was on. As per his location, he moved from Mumbai to Lonavala via road. We

learned that he has a resort in Lonavala and hence a couple of teams were sent there," said a police official. He continued, "When our team reached there, he was not there. We learnt that he moved out two hours before we reached the spot."

The police team returned to Ghatkopar on Wednesday early morning as they were needed for bandobast duty in regards to Narendra Modi's roadshow rally. Now, as per the new plan, a set of teams of police and Crime Branch will be sent to Gujarat to locate Bhinde, said police sources. They also added that

Bhinde's one number has been traced, which he is alusing communicate with his family, relatives and friends. "As per movements, moved from Lonavala via Nashik and entered Gujarat," said the source. Meanwhile, police have informed their intel in and around Gujarat to keep an eye on his movements along with the local police.

Five teams have been actively looking for Bhinde, while the technical team is assisting the investigating team with call data records (CDR) and location. The businessman, who has been fined 21 times under the Mumbai Municipal Corporation Act for illegal hoardings, has a rape case registered against him with the Mulund police in January. He also contested as an independent candidate in the 2009 Assembly polls from Mulund, and lost.

In the fresh FIR by the Pant Nagar police, Bhinde and his company have been booked under sections 304 (culpable homicide not amounting to murder), 338 (causing grievous hurt by act endangering personal safety of others), 337 (causes hurt to any person by doing any act so rashly or negligently as to endanger human life) and 34 (common intention) of the Indian Penal

# शिट्टी फक्त वाजवण्यासाठी, लोकसभेत पाठवण्यासाठी नाही

वसई : देशाच्या संविधानाचा पाया कुणालाही मुळीच बदलता येणार नाही आणि बदलण्याचा प्रश्नच उद्भवत नाही. परंतु विरोधक याचा अपप्रचार करीत आहेत आणि लोकांमध्ये भ्रम निर्माण करीत आहेत, हा विरोधकांचा विखारी प्रचार सुरू आहे, असे वक्तव्य राज्याचे पालकमंत्री रवींद्र चव्हाण यांनी केले.

रवींद्र चव्हाण यांनी मंगळवारी दुपारी रिजन्सी बँक्वेट हॉल, नालासोपारा (पूर्व) येथे पत्रकारांशी संवाद साधला. तेव्हा ते पत्रकारांशी बोलत होते. ते म्हणाले, इथेनॉलमुळे ४०% खर्चाची बचत झाली. त्यामुळे केंद्र व राज्य सरकारकडून एक कोटीपेक्षा जास्त शेतकऱ्यांना मदत देण्याचे काम

सरकार करू शकले. आज सर्वात जास्त पेटंट आपल्या देशात निर्माण होतात, याचा प्रत्येक भारतीयाला अभिमान आहे. वाढवण बंदराचा विचार बाळासाहेबांपासून सुरू होता. विरोधक अपप्रचार करतात. यामध्ये स्थानिक लोकांच्या भावनेचा विचार करूनच निर्णय घेतला जाईल, असे ते म्हणाले.

स्थानिक मुद्दे लोकसभेला महत्त्वाचे नाहीत. शिट्टी फक्त वाजवण्यासाठी असते, लोकसभेत

पाठवण्यासाठी असू शकत नाही, असा टोला त्यांनी बहुजन विकास आघाडीला लगावला. ते म्हणाले, ही निवडणूक गल्लीतली नाही, तर दिल्लीतली आहे. ह मतदारांनी समजून घ्यावे. देशाची सुरक्षा करण्याचे क एका बहुजन विकास आघाडीला शक्य नाही. योग्य उमेदवाराला मतदान करा, चुकीच्या व्यक्तीला नको, असे आवाहन त्यांनी केले.

३. ८ फेब्रुवारी, २०२४ रोजी कंपनीच्या संचालक मंडळाने विभक्तीकरणाच्या माध्यमातून मुकंद सुमी मेटल प्रोसेसिंग लिमिटेड (''एमएसएमपीएल''), कंपनी करिता एक संपूर्ण मालकीची उपकंपनी मधून स्टेनलेस स्टील कोल्ड फिनिश्ड बार्स आणि वायर्स व्यवसायाच्या हस्तांतरणा साठी व्यवस्थेची योजना (''योजना'') विचारात घेऊन मंजुर केली (''विभक्तीकरण''). एमएसएमपीएल ही कंपनीची संपूर्ण मालकीची उपकंपनी असल्याने, विभक्तीकरणानंतर

कंपनीने एमएसएमपीएल सह संयुक्तपणे योजना राष्ट्रीय कंपनी विधी न्यायाधिकरण, मुंबई खंडपीठ (''नामदार एनसीएलटी'') समोर सादर केली. एनसीएलटी आदेशाच्या अनुपालनांत, विविध नियामक प्राधिकरणांकडे सूचना जारी करण्यांत आल्या अन्य गोष्टींसह योजना नियामक प्राधिकरणे आणि नामदार एनसीएलटी कडून संतती आणि/िकंवा मंजुऱ्या मिळण्याअधीन असेल. योजनेची मंजुरी प्रलंबित असल्याने, चालू वित्तीय विवरणांमध्ये विभक्तीकरणाचा कोणताही परिणाम विचारात घेतलेला नाही.

४. मागील तिमाहीच्या आकडेवारी ह्या संपूर्ण आर्थिक वर्षाच्या संबंधातील लेखापरीक्षित आकडेवारी आणि मर्यादित पुनर्विलोकन होण्याच्या अधीन असलेल्या चालू आर्थिक वर्षाच्या तिसऱ्या तिमाही पर्यंत तारखेपर्यंत वर्षाच्या प्रकाशित आकडेवारी दरम्यानच्या तौलानिक आकडेवारी आहेत.
