The cut-off date for determining the eligibility of members to vote through Remote e-Voting and e-Voting during the AGM is **Friday, September 22, 2023**. The voting rights of the members shall be in proportion to their shareholding in the paid up share capital of the Company as on the cut-off date being September 22, 2023.

The remote e-voting commences on Tuesday, September 26, 2023 (09:00 A.M.) and ends on Thursday, September 28, 2023 (05:00 P.M.)
