Brief Summary of the Fraud: The Company is in transport business from last 25 years. The Company is having its Branch office at Jharsuguda from last 10 years. Mr. Chena Ram Saini, Mr Manoj Jha, Mr Manoj Kumar Tiwari was appointed in the Branch as employees. On date 7th April 2021, the said 3 employees had left the branch without giving any information/notice. After that in the mid April 2021, it was suspicious by the Accounts team of Jharsuguda Branch that some inappropriate activities were carried out by the said employees in the Branch. On detailed investigation it was seen that there was misappropriation of funds by way of fake challans and entries in the Accounts. To curb the activities forthwith, the Company in lieu of remedial actions immediately filed a First Information Report (FIR) at Jharsuguda police station dated 27th April 2021.
