CERTIFIED TRUE COPY OF EXTRACT OF THE MINUTES OF THE 76<sup>TH</sup> BOARD MEETING OF ESSAR SHIPPING LIMITED HELD ON MONDAY, MAY 30, 2022 AT 11.30 AM AND CONCLUDED AT 5.15 PM HELD THROUGH VIDEO CONFERENCE AND RECORDED AT 5<sup>TH</sup> FLOOR, ESSAR HOUSE, 11 K.K. MARG, MAHLAXAMI, MUMBAI-400034

To consider and approve the requests received from M/s. Arcelor Mittal Nippon Steel (AMNS) Limited (FKA Essar Steel India Limited) for re-classification from "Promoter & Promoter Group Category to public Category"

The Board was informed that M/s. Arcelor Mittal Nippon Steel (AMNS) Limited (FKA Essar Steel India Limited) holding 12,73,611 (Twelve Lakh Seventy three Thousand six hundred and eleven only) equity shares had vide their letter dated May 26, 2022 (received by the Company on May 27, 2022) requested the Company for re-classification of their shareholding from Promoter & Promoter Group Category to Public Category.

The Board was also informed about the rationale for such re-classification that AMNS is not a group Company anymore as it was acquired as a going concern, pursuant to the CIRP proceedings initiated on the Essar Steel India Limited.

Further the Board was also briefed that AMNS had specifically mentioned in their respective requests that they are satisfying all the conditions specified in sub clause (i) to (vii) of clause (b) of sub-regulation 3 of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('the Listing Regulations') and also confirmed that at all times from the date of such re-classification/removal of name, they shall continue to comply with conditions mentioned in sub-clauses (i), (ii) and (iii) of



Clause (b) of sub-regulation 3 of Regulation 31A and shall also comply with conditions mentioned at Sub- clause (iv) and (v) of clause (b) of Sub- regulation (3) of Regulation 31A of the Listing Regulations for a period of not less than three years from the date of such reclassification/removal of name, failing which they shall automatically be reclassified as promoter/persons belonging to Promoter Group as applicable.

Accordingly on the basis of the rationale and the confirmation provided by them in accordance with provisions of Regulation 31A of the Listing Regulations the Board was of the view that the above mentioned requests for reclassification/removal of name be accepted and approved by the Board of Directors of the Company, which shall be subject to the approval of Stock Exchanges and/or such other approval, if any, as may be necessary in this regard.

The Board was also informed that none of the Directors of the company is/are interested in this resolution.

The Board considered the matter and passed the following resolution unanimously:

"RESOLVED THAT pursuant to the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and any other relevant provisions, including any modification(s) or re-enactment(s) thereof for the time being in force, subject to approval of members of the Company; approval of the Board is hereby accorded for re-classification of Arcelor Mittal Nippon Steel (AMNS) Limited (FKA Essar Steel India Limited) from "Promoter & Promoter Group Category" to "Public Category"

**RESOLVED FURTHER THAT** the Board hereby authorizes the Company Secretary to take all such steps as may be necessary, proper and expedient to give effect to the foregoing resolution."
