## Sub : Intimation of adjustment in the exercise price of the employee stock options granted under the ESOP Schemes

We wish to inform you that in accordance with the Composite Scheme of Arrangement amongst Borosil Limited (the 'Company'), Klass Pack Limited (renamed as 'Borosil Scientific Limited') ('BSL') and Borosil Technologies Limited ('Composite Scheme of Arrangement'), sanctioned by the Hon'ble NCLT, Mumbai Bench on November 02, 2023, the Scientific and Industrial Products business of the Company has been demerged and consolidated into BSL.

Prior to the Composite Scheme of Arrangement, the Company had implemented two ESOP Schemes viz. a) Borosil Limited - Special Purpose Employee Stock Option Plan 2020 ('ESOP 2020'); and b) Borosil Limited - Employee Stock Option Scheme 2020 ('NEW ESOS 2020'), under which employee stock options were granted to certain eligible employees.

In order to restore the value of the employee stock options through a fair and reasonable adjustment, following the implementation of the Composite Scheme of Arrangement, the Nomination and Remuneration Committee ('NRC') of the Board has approved an adjustment in the exercise price of the employee stock options granted by the Company, as under:
