मुंबई गोवा राष्ट्रीय महाम ार्गाच्या पळरूपे ते इंदापुर किमी लांबीच्या चौपदरीकरणाचे काम संथ गतीने सुरू आहे. महामार्गाच्या चौपदरीकरणाचे काम पाच ते सहा वर्षापासून रेंगाळत सुरू आहे. आता गणेशोत्सव तोंडावर आला आहे, अशातच महामागीची प्रचंड दरावरऱ्या झाली आहे. चाकरमानी, गणेशभक्तांचा आदळत आपटत होणार आहे. खड्यात रस्ता की रस्त्यात खड्डा हे ओळखणे कठीण झालं आहे. प्रवाशी व वाहन चालकांचे अतोनात हाल होत आहेत मे महिण्याच्या अखेरपर्यंत बहुतांश ठिकाणी डांबरीकरणाचे काम पुर्ण झाले आहे. मात्र आता नविन मार्गावर पावसामुळे पुन्हा चाळण झाली आहे. त्यामुळे वाहन चालक व प्रवाश्यांना खड्ड्यातुन प्रवास लागत आहे. खड्डे चुकविताना होणाऱ्या अपघाती घटनांचे प्रमाण वाढले आहे. तसेच रिफ्लेक्टर व पांढरे पट्टे नसल्याने रात्रीच्या वेळी चालवितांना अडथळा येतो.

पावसामुळे या मार्गावर आता काही ठिकाणी मोठाले खड्डे पडले आहेत. काही ठिकाणी हे खड्डे ्रटापेक्षाही जास्त आहेत. खड्ड्यात पाणी साचल्याने खड्ड्याचा नसल्याने मोटारसायकलस्वार कोसळण्याच्या घटनांत वाढ झाली आहे. तसेच मोठ्या खड्यांमध्ये वाहन आपटून अपघात होण्याचा

महामार्गावर अनेक ठिकाणी लेनचे काम करण्यासाठी रस्ता दुभागण्यात आला आहे. ज्या ज्या ठिकाणी अशाप्रकारे रस्ता दुभागण्यात आला आहे तेथे खड्डे पडले आहेत. किंवा तेथील खडी व डांबर निघाले आहे. त्यामुळे अशा दुभाजकाच्या मार्गावरून जातांना वाहन चालकांची गैरसोय होते. तसेच अनेक वेळा वाहन येथून घसरतात व अपघाताचा धोका निर्माण होतो.
