## **Sub : Intimation for 2% change in share holding**

This is to inform you that as on 31<sup>st</sup> May 2022 , I along with persons acting in my concert were holding 1,65,00,000 equity shares (i.e. 6.1695 % ) of Delta Corp Limited.

From the period from 1<sup>st</sup> June 2022 to 10<sup>th</sup> June 2022, I along with persons acting in my concert have reduced the holding by 60,00,000 equity shares of Delta Corp Limited which is 2.2435% of the total issued and paid up capital of Delta Corp Limited of 26,74,44,801 equity shares (FV Re.1/- each).

On 13<sup>th</sup> June 2022 and 14<sup>th</sup> June 2022, I have further sold 15,00,000 equity shares which is 0.5609% of the total issued and paid up capital and there by resulting in total change of 2.8043% of the total issued and paid up capital of Delta Corp Limited of 26,74,44,801 equity shares (FV Re.1/- each).

This takes our total shareholding to 90,00,000 equity shares of Delta Corp Limited which is 3.3652% of the total issued and paid up capital of Delta Corp Limited.
