Sub: Consolidated Scrutinizer's Report on voting by remote e-voting and e-voting facility provided to the shareholders during the 49th Annual General Meeting (AGM) of the shareholders of Panasonic Energy India Company Limited held on Wednesday, 22nd September, 2021 at 11:00 A.M. through Video Conference (VC) / Other Audio Visual Means (OAVM).

I, Vijay J Bhatt, Proprietor of Vijay Bhatt & Co. - 2. The Compliance with the provisions of the Companies Act, 2013 and the Rules made there under relating to e-voting (which includes remote e-voting and the electronic voting, provided at the AGM) to the Members on the Resolutions proposed in the Notice calling the 49th AGM of the Company is the responsibility of the management. My responsibility as a Scrutinizer was to ensure that the voting process is conducted in a fair and transparent manner, and render a Consolidated Scrutinizer's Report on the voting to the Chairman on the Resolutions.
