Dear Shareholder,

Subject: Kirloskar Pneumatic Company Limited – Communication on Interim Dividend for the financial year 2021–2022 and Deduction of Tax at Source ('TDS')

We hope that you and your family are doing well and are safe and healthy.

We are pleased to inform you that the Board of Directors of the Company at its meeting held on 28 January 2022 has declared an Interim Dividend of Rs. 1.60 per Equity Share having Nominal Value of Rs. 2 each (i.e. 80 percent) for the financial year 2021–2022 and has fixed the Record Date as Wednesday, 9 February 2022 for determining eligibility of members to receive dividend.

Interim dividend will be paid on or after 24 February 2022 through various modes of payment such as Direct Credit, NEFT, RTGS, NECS, Dividend Warrants or Demand Drafts, as the case may be, to those Members whose names appear as Beneficial Owners as at the end of the business hours on 9 February 2022 in the list of Beneficial Owners to be furnished by National Securities Depository Limited and Central Depository Services (India) Limited in respect of equity shares held in electronic form; and whose names appear as Members in the Register of Members of the Company on 9 February 2022.

In accordance with the provisions of the Income Tax Act, 1961 (the Act) as amended from time to time, dividend declared and paid by a company is taxable in the hands of shareholders and the company is required to deduct tax at source (TDS) from dividend paid to the shareholders at the applicable rates. We shall therefore be required to deduct tax at source at the time of making the payment of the said dividend.

Tax rate applicable to a shareholder depends upon residential status and classification as per the provisions of the Act. All Shareholders are thereby requested to update any change in residential status and/or category with depository participants (in case of shares held in electronic form) or with the RTA, i.e. Link Intime India Private Limited (in case of shares held in physical form), as may be applicable, on or before the Cut-off Date i.e. 9 February 2022.

This communication summarizes applicable TDS provisions for Resident Shareholders and Non-Resident Shareholders as per the Act :

For Resident Shareholders:

Tax will be deducted at source under Section 194 of the Act at the rate of 10 percent on the sum of dividend payable unless exempt under any of the provisions of the Act. However, in case of individuals, TDS would not apply if the aggregate of total dividend paid to that individual by the Company during the financial year 2021–2022 does not exceed the sum of Rupees Five Thousand.

TDS will not be deducted in cases where a Shareholder provides Form 15G (applicable to any person other than a Company or a Firm) or Form 15H (applicable to an individual above the age of 60 years), provided that eligibility conditions are being met. Form 15G / Form 15H can be uploaded at below link provided by the RTA (i.e. Link Intime India Private Limited):

TDS will not be deducted, if a Shareholder is exempted from TDS provisions through any circular(s) or notification(s) and provides an attested copy of the Income Tax Permanent Account Number ("PAN") along with documentary evidence in relation to the same.

Needless to mention that the PAN is required mandatorily. If details of your PAN are available in your demat account for shares held in electronic form or with the RTA for shares held in physical form, then there is no need to submit again details of PAN to the Company. If PAN is not available or invalid, TDS would be deducted at the rate of 20 percent as per Section 206AA of the Act.

In order to provide exemption from withholding of tax, following organisations must provide a self-declaration as listed below:

- **Insurance companies**: A declaration that it has full beneficial interest in the shares along with self-attested copy of PAN and the Registration Certificate.
- Mutual Funds: A declaration that it is a mutual fund governed by the provisions of Section 10(23D) of the Act and is covered under Section 196 of the Act, along with self-attested copy of PAN and valid SEBI Registration Certificate or Notification.
- Alternative Investment Fund (AIF) established in India: A declaration that its dividend income is exempt under Section 10(23FBA) of the Act and it has been granted a certificate of registration as Category I or Category II AIF under the SEBI Regulations, along with self-attested copy of PAN and valid SEBI Registration Certificate or Notification.
- **New Pension System Trust**: A declaration that they are governed by the provisions of Section 10(44) [Subsection 1E to Section 197A] of the Act along with self-attested copy of registration documents.
- Corporation established by or under a Central Act: A declaration that it is a corporation established by or under a Central Act whereby income-tax is exempt on the income and accordingly, covered under Section 196 of the Act, along with self-attested copy of PAN and valid SEBI Registration Certificate or Notification.
- Recognised Provident Fund / Approved Gratuity / Superannuation Fund: Necessary documentary evidence as per Circular No. 18/2017 issued by Central Board of Direct Taxes.

In case of other Resident Shareholders having the Order under Section 197 of the Act, TDS will be deducted at the rate mentioned in the Order; provided the Shareholder submits copy of the Order obtained from the income-tax authorities.

For Non-Resident Shareholders:

Tax is required to be withheld in accordance with the provisions of Section 195 of the Act at applicable rates in force. As per the relevant provisions of the Act, the tax shall be withheld at the rate of 20 percent (plus applicable surcharge and cess) on the sum of dividend payable.

Further, in the case of Foreign Institutional Investors and Foreign Portfolio Investors, tax shall be deducted at source at the rate of 20 percent (plus applicable surcharge and cess) under Section 196D of the Act.

However, as per Section 90 of the Act, a non-resident shareholder has the option to be governed by the provisions of the Double Tax Avoidance Agreement ("DTAA") between India and the country of tax residence of the shareholder, if they are more beneficial to the shareholder.

For this purpose, i.e. to avail the tax treaty benefits, the Non-Resident Shareholder (including FII and FPI) will have to provide the following:

- Self-attested copy of PAN card, if any, allotted by the income tax authorities of India.
- Self-attested copy of Tax Residency Certificate ("TRC") issued by the tax authorities of the country of which the shareholder is resident, evidencing and certifying shareholder's tax residency status during the financial year 2021–2022.
- Self-declaration in Form 10F duly filled and signed.
- SEBI registration certificate in case of Foreign Institutional Investors and Foreign Portfolio Investors.
- Self-declaration in the prescribed format certifying that :
 - (a) The shareholder is eligible to claim the beneficial Tax Treaty rate for the purposes of withholding tax on dividend declared by the Company;
 - (b) Transaction / arrangement / investments, from which the dividend is derived by the Shareholder, is not arranged in a manner which results in obtaining a tax benefit, whether directly or indirectly, as one of its principal purposes. The tax benefit, if any, derived from such transaction / arrangement / investments would be in accordance with the object and purpose of the provisions of the relevant Tax Treaty ('the Principle Purpose Test', if applicable to the respective Tax Treaty);
 - (c) No Permanent Establishment / fixed base in India during the financial year 2021–2022 in accordance with the applicable tax treaty;
 - (d) The shareholder is the ultimate beneficial owner of its shareholding in the Company and dividend receivable from the Company.

The Company is not obligated to apply the beneficial DTAA rates at the time of tax deduction / withholding on dividend sums. Application of beneficial DTAA rate shall depend upon the completeness and satisfactory review by the Company of the documents submitted by a Non-Resident Shareholder.

In case of Non-resident shareholder having the Order under Section 197 of the Act, TDS will be deducted at the rate mentioned in the Order, provided the Shareholder submits copy of the Order obtained from the income-tax authorities.

Where any entity is entitled to exemption from TDS, TDS will not be deducted provided such shareholder entity provides valid self-attested documentary evidence (e.g. relevant copy of registration, notification, order, etc. issued by the tax authorities of India).

For All shareholders

The Finance Act, 2021 has introduced Section 206AB of the Act w.e.f. 1 July 2021, whereby tax would be required to be deducted at twice the applicable rate in respect of any sum or amount or income paid or payable or credited to a 'specified person'.

Further, the Act defined 'specified person' to mean:

- A person who has not filed returns of income for both of the two assessment years relevant to the two previous years immediately prior to the previous year in which tax is required to be deducted and the time for filing tax return under section 139(1) of the Act has expired for both these assessment years; and
- aggregate of tax deducted at source and tax collected at source in his/her case is Rs. 50,000 or more in each of these two previous years.

However, the aforementioned withholding at higher rate shall not apply to a Non-Resident who does not have a Permanent Establishment / fixed base in India. Accordingly, a Non-Resident should submit a No Permanent Establishment declaration (as referred above, wherever applicable).

Notes:

- 1. All the above referred tax rates will be enhanced by surcharge and cess, as applicable.
- 2. For all self-attested documents, shareholders must mention on the document "certified true copy of the original". For all documents being uploaded by the shareholder, the shareholder undertakes to send the original document(s) on request by the Company.
- 3. In case tax on dividend is deducted at a higher rate in the absence of receipt of the aforementioned details / documents, the concerned Shareholder would still have the option of claiming refund at the time of filing the income tax return. No claim shall lie against the Company for such deduction of taxes.
- 4. In the event of any income tax demand (including interest, penalty, etc.) arising from any misrepresentation, inaccuracy or omission of information provided / to be provided by the Shareholder(s), such Shareholder(s) will be responsible to indemnify the Company and also, provide the Company with all information / documents and co-operation in any proceedings.
- 5. Documents furnished by the shareholders [such as Form 15G/15H, TRC, Form 10F, Self-Attested Declaration etc.] shall be subject to review and examination by the Company before granting any beneficial rate or Nil Rate. The Company reserves the right to reject documents in case of any discrepancies or documents are found to be incomplete. Decision of the Company with respect to the validity of any document will be final.
- 6. In case of any discrepancy in documents submitted by the Shareholder, the Company will deduct tax at higher rate as applicable, without any further communication in this regard.
- 7. The Company will withhold taxes as per the stipulated tax laws prevalent at the time of deduction of taxes.
- 8. Shareholders holding shares under multiple accounts under different status / category and having single PAN, may note that, higher of the tax as applicable to the status, in which shares are held under a PAN, will be considered on their entire holding in different accounts.
- 9. A declaration must be filed with the Company where the whole or any part of the dividend income is assessable, under the provisions of the Act, in the hands of a person other than the shareholder in accordance with Rule 37BA(2) of the Income-tax Rules, 1962. The declaration must consist of Name, address, PAN of the person to whom credit is to be given and proportion of credit to be given in respect of dividend income. In case company does not receive such declaration before 15 May 2022, the Company reserves the right to reject such declaration.

To enable us to determine appropriate TDS / withholding tax rate applicable, you should upload necessary documents at https://linkintime.co.in/formsreg/submission-of-form-15g-15h.html before Wednesday, 9 February 2022.

No communication on tax determination / deduction shall be considered after 9 February 2022.
