SUMMARY OF THE PROCEEDINGS OF THE 01ST EXTRA-ORDINARY GENERAL MEETING OF DEEP DIAMOND INDIA LIMITED PURSUANT TO REGULATION 30(6) OF THE SEBI LISTING REGULATIONS

The 01st Extra-Ordinary General Meeting (EOGM) of the Company was held on Friday, December 08, 2023, through Video Conference Mode (VC) in accordance with the applicable provisions of Companies Act, 2013 read along with the rules issued thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. The deemed venue for the EOGM was the registered office of the Company.

The meeting commenced at 11:30 A.M.

On request of Ms. Sonali Laddha; Mr. Ganpat Lal Nyati, Chairman of the Company, chaired the proceedings of the 01st EOGM and extended a warm welcome to all Directors and Shareholders of the Company to the EOGM and then introduced all the Directors to the members.

All the six Directors including the Chairman of the Audit Committee, Nomination and Remuneration Committee & Stakeholder Relationship Committee attended the EOGM. The representative of the statutory auditors and scrutinizers to the EOGM also attended the EOGM.

Mr. Prashant Tali, Company Secretary and Compliance Officer of the was unable to attend the EOGM due to a certain medical emergency.

The members were informed that all the efforts feasible under the circumstances have been indeed made by the Company to enable the members to participate in the EOGM through video conferencing and vote on the items proposed in the notice of the EOGM as per the provisions of Companies Act, 2013 and SEBI Listing Regulations.

The Chairman then informed that the Company had tied up with National Securities Depositories Limited (NSDL) to provide facility for voting through remote e-voting, e-voting during the EOGM and participation in the EOGM through VC / OAVM facility. The Company has extended the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the EOGM.

Further Ms. Sonali Laddha provided general instructions to the members regarding participation in the meeting. She, inter alia, informed the members about the following:

- a. The remote e-voting period which commenced on Tuesday, December 05, 2023, at 9:00 A.M. and ended on Thursday, December 07, 2023, at 5:00 P.M.
- b. The Company had provided a facility to the members to cast their votes electronically, on all resolutions set forth in the Notice convening the 01st EOGM of the Company.
- c. The Board of Directors of the Company at their meeting held on November 08, 2023, had appointed, Mr. Ronak Jhuthawat of M/s. Ronak Jhuthawat & Co., Practicing Company Secretaries, as the Scrutinizer for scrutiny of the votes cast through the remote e-voting platform and electronic voting at the EOGM.
- d. The documents which are statutorily required to be kept open for inspection were available electronically for inspection by the members and those who want the access can email the Company. The Chairman then continued delivering his speech to the shareholders of the Company which included highlights on business performance, financials, outlook, etc.

The Notice convening the 01st EOGM of the Company of the Financial Year 2023-2024, were taken as read by the Chairman as the same were already circulated to the members.

Thereafter the Chairman took over and proceeded to explain the conduct of the meeting and placed the following resolutions as set out in the notice convening the 01st EOGM.
