Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”)

We would like you to take note of our financial performance for Q1FY24:

- Revenue from operation: Revenue from operation decreased to INR 1,658.59 in Q1FY24 from 5,420.85 in Q1FY23 due to no new Occupation Certificate (OC) received in this quarter.
- Profit/(loss) after tax (PAT): PAT has been reduced to Loss of INR 71.80 million in Q1FY24 as compared to Profit of INR 327.87 million in Q1FY23.
- Adjusted Gross Profit margin: Adjusted Gross Profit margin improved to 34.33% in Q1FY24 as compared to 26.91% in Q1FY23.
- Adjusted EBITDA margin: Adjusted EBITDA margin reduced to 9.53% in Q1FY24 as compared to 18.21% in Q1FY23.
