Reference your E-mail dated 09.08.2022 regarding the captioned subject matter wherein you mentioned that you & Mr. Hari Mohan Lal Beri could not dematerialise the 35 shares each respectively of IFGL Refractories Ltd.

Kindly be informed you that the Face Value of Equity Shares was reduced from Rs.10 to Rs.3.50 in the year 1996 with approval of Hon'ble Orissa High Court and subsequently, new 35 Equity Shares of Rs. 10/- each paid up were issued and allotted. Even those 35 Equity Shares have ceased to exist following amalgamation of erstwhile IFGL Refractories Ltd with this Company (previously known as IFGL Exports Ltd) approved by the Hon'ble National Company Law Tribunal Bench, Kolkata by passing an Order on 3rd August, 2017. Following this amalgamation 1(one) Equity Shares of Rs.10/-each fully paid of the Company was issued and allotted 1(one) Equity Share of Rs. 10/- each fully paid held in erstwhile IFGL Refractories Ltd. Certificate No.2497 & 5994 under Folio Nos. 002467 & 005964 for 35 Equity Shares of Rs. 10/- each respectively was issued by the Company for the said

holding of 35 Equity Shares each respectively in erstwhile IFGL Refractories Ltd and these 35 Equity Shares each respectively has been sent to Mr. Hari Mohan Lal Beri & your address recorded with us and the same has not been returned undelivered with us.
