In terms of Regulation 29 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is hereby informed that a meeting of the Board of Directors of the Company is scheduled to be held on Tuesday, 31st January, 2023, inter-alia for the following:-

- i) to consider and approve unaudited Consolidated and Standalone Financial Results for the quarter and nine months ended on 31st December, 2022.
- ii) to declare Interim Dividend, if any, for the Financial Year 2022-23.
- 2. Pursuant to Regulation 42 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, the Company has fixed **Wednesday**, **08**th **February**, **2023** as "**Record Date**" for the purpose of determining the eligibility of Members entitled to receive the Interim Dividend for the FY 2022-23, if any, which is subject to approval of the Board. The Interim Dividend would be paid within 30 days from the date of its declaration at the Board Meeting.

The Trading Window for dealing in equity shares of RailTel has already been closed for designated persons and their immediate relatives with effect from Sunday, 1st January, 2023 till expiry of forty eight (48) hours after the declaration of Unaudited Financial Results for the quarter and nine months ended on 31st December, 2022.
