Sub: Scrutinizer's Report on Postal Ballot through e-voting conducted in pursuance to the provisions of Sections108 and 110 of the Companies Act, 2013 and Rules20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended.

We, M/s. Anant B. Khamankar & Co., Practicing Company Secretaries, wereappointed as the Scrutinizer by Bajaj Electricals Limited(the "Company") pursuant to the provisions of Sections 108 and 110 of the Companies Act, 2013 ("Act") and Rules 20 and 22 of the Companies (Management and Administration) Rules 2014, as amended by the Companies (Management and Administration) Amendment Rules, 2021, to the extent applicable, for the purpose of scrutinizing the Postal Ballot process conducted through remote e-votingin a fair and transparent manner and ascertaining the requisite majority on remote e-voting as per the provisions of the Act.

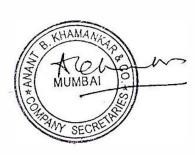
