1. I am, holding 100 equity shares representing 0.0003% voting rights in the equity shares of the Target Company ("DERL") through direct holding.
2. Dharen Savla Family Trust (DSFT) was one of the beneficiaries of Shantilal Savla Family Trust (SSFT) which held 4062576 equity shares representing 12.6956 % voting rights in the equity shares of DERL. As i was one of the beneficiaries in DSFT and therefore my name has been disclosed as a significant beneficial owner (SBO) in respect of the equity shares held by SSFT in DERL.
3. However pursuant to Memorandum of Family Arrangement, DSFT has also relinquished its beneficiary rights and interest in SSFT in respect of the equity shares of the DERL w.e.f 25<sup>th</sup> January, 2023.
4. After the relinquishment of beneficiary rights of DSFT in the SSFT in respect of shares of DERL, DSFT has ceased to be a beneficiary in SSFT and accordingly I ceased to be a SBO w.e.f \_25<sup>th</sup> January, 2023. However, I continue to hold 100 equity shares of DERL in form of direct shareholding.
