



25,867,947 Equity Shares will be transferred from Mrs. Versha Kajaria and Mr. Chetan Kajaria in their capacity as the joint trustees of the Rishi Kajaria Family Private Trust to RK Trustees Private Limited in its capacity as the new trustee of the Rishi Kajaria Family Private Trust.


In terms of Regulation 10(1)(a)(iii) of the Takeover Regulations, an acquisition pursuant to a transfer between a company and persons holding not less than 50% of the equity shares carrying voting rights of such company, is exempt from the obligation to make an open offer. In the present case, upon change of trustees of Rishi Kajaria Family Private Trust, the equity shares held by Mrs. Versha Kajaria and Mr. Chetan Kajaria in their capacity as trustees of Rishi Kajaria Family Private Trust would be transferred to RK Trustees Private Limited in its capacity as a trustee of Rishi Kajaria Family Private Trust. Mrs. Versha Kajaria and Mr. Chetan Kajaria in turn control and own 100% of the equity share capital of RK Trustees Private Limited. Therefore, such acquisition by RK Trustees Private Limited would be pursuant to a transfer between a company (i.e. RK Trustees Private Limited) and persons holding not less than 50% (i.e. Mrs. Versha Kajaria and Mr. Chetan Kajaria) of the equity shares of such company. Accordingly, the change of trustees of Rishi Kajaria Family Private Trust as contemplated above would have the benefit of the exemption under Regulation 10(1)(a)(iii). Also, there is no change taking place in the aggregate shareholding of the promoter/promoter group of the Target Company.
