The financial results for the quarter ended 31st DECEMBER 2018, are presented as per the requirements of IND AS as notified by the Ministry of Corporate Affairs under Companies (Indian Accounting Standards) Rules, 2015.

During the quarter ended 31st DECEMBER 2018, the company has adopted its policy of revenue recognition in line with Ind As 115 'Revenue from Contracts with Customers', which has come into force with effect from 01.04.2018 as notified by the Ministry of Corporate Affairs. Accordingly the contract income is recognised on completion of performance obligation as against recognition of income on percentage completion method hitherto followed in accordance with the guidance note issued by ICAI. The cumulative effect of initial application of Ind As 115 upto March 2018 has been adjusted in opening retained earnings as permitted by the Standard. There is no significant impact on the financial results for the quarter ended 31st DECEMBER 2018. However, the performance of the quarter ended 31st DECEMBER 2018 has resulted in loss on account of change in accounting income recognition.
