Gadkari, Chouhan out as BJP reshuffles Parl board

Sonowal, Yediyurappa included; Iqbal Lalpura first Sikh to find a place on board

New Delhi, 17 August

The Bharatiya Janata Party (BJP) on Wednesday reshuffled its apex decision-making body, the parliamentary board, dropping two important members — Union minister Nitin Gadkari and chief minister of Madhya Pradesh Shivraj Singh Chouhan.

Important election and candidate-related decisions are taken by the parliamentary board.

It had a large number of vacancies after the death of Arun Jaitley, Sushma Swaraj, Ananth Kumar and the elevation of Venkaiah Naidu as vice-president and Thawar Chand Gehlot as Karnataka Governor.

The parliamentary board works in tandem with the Central Election Committee (CEC) and members of the board are also members of the CEC.

No member of the parliamentary board has really been dropped, said a BJP leader from Delhi. But when vacancies arise, they are filled up from among appropriate persons available.

The BJP's organising secretary, "lent" by the RSS to the BJP, is ex-officio member of the parliamentary board.

Accordingly, BLSanthosh finds a place on the parliamentary board, but the addition of former Karnataka chief minister BS Yediyurappa is a balancing factor.

Both of them are from Karnataka's Shimoga district and have been RSS workers.

Yediyurappa had briefly left the BJP in 2012 to form

Sudha Yadav, another new entrant, is from Haryana and has a PhD from IIT Roorkee. When Narendra Modi was BJP general secretary of Haryana, Yadav contested the Lok Sabha election for the first time, and was pressed for resources.

On that occasion, Modi reached into his pocket, took out ₹11 that his mother had given him some years ago, and donated that for Yadav's election campaign. He asked all present to empty their pockets of all cash except their fare back, and contribute. Yadav recalled that within 30 minutes, her election campaign fund had swelled to ₹7.5 lakh.

Satyanarayan Jatiya from Madhya Pradesh is a Dalit, who was labour minister in the Atal Behari Vajpayee government.

Sarbanand Sonowal's inclusion is a reward for not protesting after being uprooted from Assam. But it would make Himanta Biswa Sarma wary. The Assam chief minister's political fortunes have been soaring since he joined the BJP from the Congress a few years ago.

By these inclusions, the BJP has ensured social and regional balance.

The CEC was also revamped with the inclusion of Union minister Bhupender Yadav, Om Mathur, and BJP women's wing chief Vanathi Srinivasan.

Bihar leader Shahnawaz Husain and tribal leader Juel Oraon have been dropped from the CEC.

"Gadkari's exclusion and Devendra Fadnavis's inclusion in the CEC tells its own story," said a BJP leader.

The omission of ex-BJP president marks their diminishing stock within the party

his own party, the Karnataka Janata Paksha.

While his party was not much of an electoral success, his exit influenced the outcome of the 2013 Karnataka Assembly elections in which the BJP could not form the government. Karnataka will go to assembly polls in 2023.

CBIC revises guidelines on arrest, prosecution for Customs violations

Central Board of Indirect Taxes & Customs (CBIC) has streamlined the monetary limit for exercising arrest, prosecution and bail with respect to offences committed under the Customs Act. While revising these guidelines, the circulars, issued on August 16, also provided detailed scenarios, which could trigger action like arrest for violating the Customs rules.

According to the indirect tax body's circulars, outright smuggling of high-value goods such as precious metals like gold and unauthorised import of goods — where market value exceeds ₹50 lakh — could trigger prosecution and arrest.

Meanwhile, cases involving duty

evasion and mis-declaration of goods worth ₹2 crore or above will also face similar action.

Similarly, if the amount of fraudulent availment of drawback or any exemption from duty in connection with export of goods exceeds ₹2 crore, it will also trigger arrest.

"While the Act (Customs) does not specify any value limits for exercising powers of arrest, it is clarified that arrest in respect of an offence should be effected only in exceptional situations," CBIC said while spelling out the scenarios.

However, this threshold of value would not apply to certain items, including ammunition and explosives, antiques, art treasures, wildlife and endangered species. "In such cases, arrest if required, on the basis of facts

and circumstances of the case, may be considered irrespective of the value of offending goods involved," the CBIC

note said. Further, for cases involving non-declaration of foreign currency exceeding ₹50 lakh by foreign nationals and non-resident Indians (NRIs) at the time of departure, prosecution need not be considered as a routine. That is, if it is claimed to be legally acquired but not declared inadvertently.

"CBIC has not merely increased the threshold monetary limit for arrest, prosecution and bail but has also provided a more illustrative list of scenarios where offences can lead to arrest. This move will help in reducing litigation and bring in more clarity for both importers and the Customs department," Saurabh Agarwal, tax partner, EY, said.

Freebies, welfare schemes must be differentiated: SC

Continuing with its hearing on the freebies matter, the Supreme Court on Wednesday observed that the difference between what can be termed freebies or welfare measures needs to be determined. The matter will be heard again on August 21.

The court said that the term freebies should not be confused with welfare measures.

A bench of Chief Justice of India (CJI) NV Ramana, Justices Hima Kohli and JK Maheshwari heard the plea seeking directions to political parties to not promise and distribute freebies to voters.

The court said the issue was getting complicated. Political parties such as AAP, Congress and the DMK had filed their replies in the matter.

The DMK had submitted that the petitioner in the case was trying to convert India from a socialist to a capitalist state. It also objected to the court's proposal to constitute a committee to examine the issue. It said that the plea, if given effect, would defeat the objectives of the Directive Principles of State Policy.

Meanwhile, the court asked what can be termed a freebie.

"Can we term the promise of free education as a freebie? Can we say subsidies for electricity or free drinking water are freebies? Can free electronics and vehicles be termed welfare measures? You (parties) give your submissions, and after a debate, we will decide," CJI Ramana said.

He also said that just because a political party makes promises before the elections does not mean the party would win the elections solely based on these promises.

Giving the example of MGNREGA, he said the scheme allowed the people to live with dignity.

The court asked the parties to not use this matter for publicity and file their submissions on Saturday. This will allow the matter to be heard on Monday.

"Ensure all parties are supplied with copies of the application," the court said.

The court — in its last hearing on August 11 — had said legislation barring political parties from offering voters freebies is not advisable. It added that de-registering them for making such promises would be "anti-democratic."

Pre-mediation in commercial cases mandatory

The Supreme Court on Wednesday held that the pre-mediation process in commercial cases is mandatory and suits not complying with this provision would be rejected.

A Bench of Justices KM Joseph and Hrishikesh Roy, in Patil Automation Pvt Ltd vs Rakhija Engineers, held that not complying with the mediation stage would defeat the purpose of the Commercial Courts Act 2015.

"We hold that any suit instituted violating the mandate of Section 12A (pre-mediation) must be visited with the rejection of the plaint. We, however, make this declaration effective from August 20 so that concerned stakeholders become sufficiently informed," the court said in the order.

The apex court said the power to reject the plaint can be exercised even suo motu by the court.

The court also clarified that in cases where plaints have been rejected and no steps taken in the period of limitation, the matter cannot be reopened based on this declaration.

Lastly, the court said if the plaint is filed violating Section 12A after the jurisdictional high court has declared Section 12A mandatory also, the plaintiff will not be entitled to relief.
