Toll Revenue for Q3FY20

Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 1.0% to Rs. 2,786.5 mn in Q3FY20 from Rs. 2,757.6 mn in Q3FY19.

ARRIL - Toll revenue (excluding car) received in Q3FY20 has increased by approx 6.4% to Rs. 257.5 mn from Rs. 242.1 mn in Q3FY19.

AJTL - Toll revenue (excluding cars and state buses) received in Q3FY20 has increased by approx 19.0% to Rs. 119.1 mn from Rs. 100.1 mn in Q3FY19.

BHTPL - Toll revenue received in Q3FY20 has reduced by approx 5.5% to Rs. 279.6 mn from Rs. 295.7 mn in Q3FY19.

HYTPL - Toll revenue received in Q3FY20 has increased by approx 9.6% to Rs. 211.6 mn from Rs. 193.1 mn in Q3FY19.

MBCPNL - Toll revenue received in Q3FY20 has reduced by approx 3.8% to Rs. 545.8 mn from Rs. 567.4 mn in Q3FY19.

DPTL - Toll revenue received in Q3FY20 has increased by approx 1.0% to Rs. 486.9 mn from Rs. 481.9 mn in Q3FY19.

RPTPL - Toll revenue received in Q3FY20 has reduced by approx 15.0% to Rs. 223.0 mn as against Rs. 262.4 mn in Q3FY19.

SUTPL - Toll revenue received in Q3FY20 has increased by approx 6.0% to Rs. 329.6 mn as against Rs. 310.8 mn in Q3FY19.

BRTPL - Toll revenue received in Q3FY20 has increased by approx 7.5% to Rs. 143.5 mn as against Rs. 133.5 mn in Q3FY19.


