**Update on COVID-19 situation for VAMA INDUSTRIES LIMITED ( “the Company”)**

- The Operations of VAMA INDUSTRIES LIMITED and its offices were shut down due to CoVID 19 pandemic effective 23<sup>rd</sup> March 2020
- Necessary guidelines for the Company have been drafted on the basis of the guidelines issued by Central/ State Government / Municipal authorities on social distancing, travel guidelines, thermal scanning, permissible number of employees, Aarogya Setu app download by its employees. Employees have been trained on the same.
- Employees have been trained on safe practices to be observed while travelling when using public facilities and also while at office.
- Since the enforcement of the lockdown, very minimum number of employees are working from home subject to availability of working Infrastructure at home, to the extent possible and due to practicality of the industry and sudden lockdown measures initiated by the Central and state government. Like other industries impact has been quite severe on us also. Sales have been adversely impacted.
- All IT Security protocols are in place and all systems are being monitored remotely to the extent wherever possible due to the practicality of the industry and sudden lockdown measures initiated by the Central and state government.
- Company has distributed food to Drivers and needy persons during lockdown period as a corporate social responsibility.



**Commencement of Operations:**

- Our operations have gradually restarted from 20<sup>th</sup> May, after receiving due clearance from the relevant government authorities thru various Circulars and notifications and with the prescribed numbers.
- We have taken up adequate measures in order to prevent the spread of Corona virus while opening (Cleanliness, Sanitization, Masks and Physical / Social Distancing).
- The opening and closing timings were strictly maintained as per guidelines given from time to time during this pandemic period by the Central/State/ Local authorities.
- Managing Director of the company communicated with the employees to address the situation and answer queries, if any from the employees.

The financial impact of Lockdown is yet to be ascertained. We shall continue to provide an update on the situation.
