We have followed up since August 2021, to issue us the duplicate share certificate, but no response has come from your end. We have shared all relevant documents related to my share certificate.

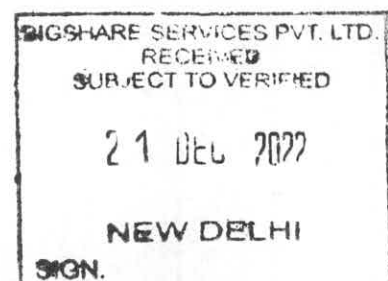
Also, We have not transferred my shares or any of them in favour of any other person, and we have not executed an instrument of transfer for our shares in favour of any person.
