गत वित्त वर्ष एलऐंडटी के सीएफओ, सीईओ के वेतन में हुई कटौती

अमृता पिल्लई मुंबई, 18 जुलाई

लार्सन ऐंड टुब्रो (एलऐंडटी) के दो मुख्य अ धिकारियों, मुख्य वित्तीय अधिकारी और प्रबंध निदेशक के वेतन में वित्त वर्ष 2023 के दौरान दो अंक की कटौती दर्ज की गई। कंपनी द्वारा हाल में जारी सालाना रिपोर्ट में इसका खुलासा हुआ है।

एलऐंडटी की वित्त वर्ष 2023 की सालाना रिपोर्ट के अनुसार, मुख्य कार्याधिकारी एवं प्रबंध निदेशक एस एन सुब्रमण्यन ने बीते वित्त वर्ष में 35.67 करोड़ रुपये का कुल पारिश्रमिक प्राप्त किया। सालाना रिपोर्ट में कहा गया है कि यह वित्त वर्ष 2022 की तुलना में 41 प्रतिशत कम था। वहीं एलऐंडटी के मुख्य वित्तीय अधिकारी और पूर्णकालिक निदेशक आर शंकर रमन के लिए भी पारिश्रमिक वित्त वर्ष 2023 में 22.56 प्रतिशत घटकर 22.17 करोड़ रुपये रह गया। सालाना रिपोर्ट के अनुसार तुलनात्मक तौर पर, सभी कर्मचारियों के लिए औसत पारिश्रमिक वित्त वर्ष 2023 में 3.06 प्रतिशत बढा। वहीं गैर-प्रबंधन संबं धित कर्मियों के लिए वेतन में औसत वृद्धि 7.72 प्रतिशत रही। कंपनी ने दो प्रमुख अधिकारियों के वेतन में कटौती के कारणों की जानकारी नहीं दी है। इस संबंध में मंगलवार को एलऐंडटी को भेजे गए ईमेल संदेश का भी कोई जवाब नहीं मिला है। वित्त वर्ष 2022 में इन दोनों शीर्ष अधिकारियों का पारिश्रमिक 100 प्रतिशत से ज्यादा बढ़ाया गया था। कंपनी के चेयरमैन एएम नाइक द्वारा जारी बयान में कहा गया है कि पूंजीगत खर्च में इजाफा हुआ है। उन्होंने कहा, 'देश के इतिहास में यह दुर्लभ अवसर हैं, जब हम भारत में पूंजीगत सुधार दर्ज कर रहे हैं। मध्य पूर्व क्षेत्र हमारे लिए एक महत्वपर्ण वैश्विक बाजार है।' 9 अगस्त को होने वाली आगामी सालाना आम बैठक कंपनी चेयरमैन के तौर पर नाइक की आखिरी बैठक होगी।

दूसरी तिमाही और उसके बाद क्या आप ग्राहकों के निर्णय लेने के चक्र में कोई प्रगति देख रहे हैं? प्रवृत्ति अभी काफी स्थिर है। मैं दूसरी तिमाही में पहली तिमाही के मुकाबले कोई खास बदलाव नहीं देख रहा हं। मझे लगता है कि हम अनिश्चितता के समान बाजार में हैं मगर आगे किसी तरह की कोई गिरावट नहीं होने वाली है। -2 फीसदी से +1 फीसदी के हमारे राजस्व से पता चलता है कि पिछली तिमाही से सुधार हुआ है, लेकिन मैं अभी यह नहीं कह सकता हूं कि परिवर्तन टिकाऊ है या नहीं।



क्या आप संगठनात्मक संरचना को चार वैश्विक व्यापार लाइनों (जीबीएल) में बदलने की जरूरत को संक्षेप में बता सकते हैं? करीब 30 वर्षों के बाद हमने संगठन को एक मैट्रिक्स में बदल दिया। इसमें बाजार की जरूरतें एक तरफ और हमारी वैश्विक व्यापार रेखा दूसरी तरफ थी। हम करीब ढाई वर्षों से इसी मॉडल पर चल रहे हैं। यह विप्रो के इतिहास में पहली बार था कि हम ऐसा मॉडल बना रहे थे। मुझे लगा कि केवल दो वैश्विक कारोबारों के साथ इस मॉडल को सरल रखने की जरूरत है। चुंकि यह

मॉडल जनवरी 2021 में दो वैश्विक कारोबारों के साथ शरू किया गया, इसलिए इसमें अभूतपूर्व वृद्धि हुई है और यह बड़े हो गए हैं। साथ ही हमारा बाजार में परिपक्व हो गया है।

क्या मॉडल का मतलब परामर्श पर अधिक ध्यान देना है?

हां. अगर आप सच में अपने ग्राहकों के साथ रणनीतिक विमर्श करना चाहते हैं तो परामर्श जरूरी है। यदि आप जटिल ऐंड टू ऐंड परिवर्तन सौदे बनाने में सक्षम होना चाहते हैं तो परामर्श क्षमताओं की जरूरत होगी। पिछले कुछ वर्षों में हमारा परामर्श व्यवसाय बहुत मजबूत हुआ है। हमने सुरक्षा क्षेत्र में कैपको, राइजिंग, एडजाइल और संचार क्षेत्र में कन्वर्जेंस एक्सेलेरेशन सॉल्युशंस (सीएस समूह) का अधिग्रहण किया है। आगे भी ऐसा करना

बड़े संभावित सौदों की क्या स्थिति है? क्या आपको लगता है कि आर्टिफिशल इंटेलिजेंस (एआई) आधारित सौदों में तेजी आएगी? हां, हम अपने संभावित सौदों को देख रहे है। एआई आधारित सौदों की संख्या काफी तेजी से बढ़ रही है।

किसी ग्राहक के साथ ऐसी कोई चर्चा नहीं हो रही है जिस पर एआई से जड़ी बातचीत न हो। उन सभी के मन में यह बात है। बड़े सौदों की बात करें तो करीब तीन साल पहले विप्रो बमुश्किल इस क्षेत्र में थी। लेकिन, पिछले तीन वर्षों में हम बड़े सौदों के लिए एक टीम बनाई है जो ऐसे सौदों को तैयार करते हैं। हम अधिक सक्रिय होने और कुछ परिवर्तनकारी विचारों के साथ ग्राहकों के पास जाने के लिए खाता अधिकारियों के साथ काम कर रहे हैं। इससे बड़े सौदों की एक मजबूत संभावना तैयार हुई है।

इस वित्त वर्ष आपके अधिग्रहण की रणनीति क्या होगी?

हमारी रणनीति वही है जो हमने अक्टबर 2020 में बनाई थी। अधिग्रहण हमारी रणनीति का एक हिस्सा है। यह रणनीतिक इरादे के परिणाम के रूप में आता है। इसलिए जब हम अधिग्रहण के लिए जाते हैं तो इसमें संख्या का महत्व और केवल स्केल हासिल करना मकसद नहीं रहता है। इसमें बाजार या उद्योग के दृष्टिकोण या फिर तकनीक के दृष्टिकोण से रणनीति भूमिका होती है। हम पिछले तीन वर्षों में किए गए 12 अधिग्रहण के बाद इसी तरह आगे बढ़ रहे हैं।

100 प्रतिशत बढ़ चुकी है। सड़क परिवहन और राजमार्ग मंत्रालय के पोर्टल वाहन के आंकड़ों के अनुसार जुलाई के पहले 17 दिनों में ई-दोपहिया वाहनों की औसत दैनिक बिक्री जून में बेचे गए 852 वाहनों की तुलना 1 जुलाई से 17 जुलाई तक ई-दोपहिया वाहनों की कुल 28,937

फेम 2 की सब्सिडी में कटौती का असर कम होने से इलेक्ट्रिक दोपहिया की बिक्री उछली गई थी।

शुरुआत में सब्सिडी कटौती का ई-दोपहिया बाजार पर नकारात्मक असर पडा था. जिससे बिक्री में गिरावट आई थी क्योंकि संभावित खरीदार ई-दोपहिया वाहन खरीदने के लाभ पर इसकी चोट का आकलन कर रहे थे। जून में ई-दोपहिया की बिक्री लगभग 60 प्रतिशत घटकर 42,124 इकाई रह गई, जबकि मई में यह 1,05,348 की बिक्री के साथ अब तक के सर्वाधिक स्तर पर थी। मई में बिक्री बढ गई थी क्योंकि ग्राहक फेम 2 के तहत दिए जाने वाले अधिक में बढ़कर 1,702 वाहन हो गई है। प्रोत्साहनों को भुनाने की दौड़ में थे। केंद्र सरकार ने 1 जून से ई-

दोपहिया के लिए अधिकतम घटाकर 22,500 रुपये कर दी। इसके साथ ही 80,000 रुपये से 1,50,000 रुपये के बीच रहने वाले ई-दोपहिया वाहन की औसत कीमत 20 प्रतिशत से अधिक तक

बढ गई। वाहन उद्योग के विशेषज्ञों का कहना है कि सब्सिडी में कमी किए जाने के बावजूद उपभोक्ता अब धीरे-धीरे लचीलापन और इसे

अपनाने का भाव दिखा रहे हैं। प्रभदास लीलाधर के अनुसंधान विश्लेषक हिमांशु सिंह ने कहा कि बिक्री में यह बढ़ोतरी ई-दोपहिया वाहनों के प्रति उपभोक्ता धारणा में सकारात्मक बदलाव का संकेत देती है और यह जारी रहने के आसार हैं। उन्होंने कहा कि जून के दूसरे पखवाड़े में बिक्री में सुधार

शुरू हुआ है। अगर जून का यह रुझान चलता रहता है, तो आगे चलकर बिक्री में उल्लेखनीय वृद्धि दिखने की संभावना है। जून के पहले 15 दिनों में रोजाना औसतन 721 वाहनों की बिक्री हुई। महीने के दूसरे पखवाड़े (16 जून से 30 जून तक) में यह

बिक्री बढ़कर 2,332 हो गई।

उद्योग के विशेषज्ञों ने कहा कि हालांकि जुलाई के पहले पखवाड़े में 1,702 वाहनों की औसत दैनिक बिक्री जून के दूसरे पखवाड़े में दर्ज की गई बिक्री (2,332) से कम है, लेकिन मॉनसून के बाद इसमें तेज इजाफा नजर आने के आसार हैं। सिंह ने कहा कि भारी बारिश के कारण जुलाई के पहले पखवाड़े में शायद औसत दैनिक बिक्री कम रही है, जिसने दिल्ली और उत्तर भारत के अन्य हिस्सों जैसे ई-दोपहिया के प्रमख बाजार को प्रभावित किया है।

तेजी से बढ़ रहे एआई आधारित सौदे : डेलापोर्ट

हाल ही में विप्रो ने कहा है कि ग्राहकों के तेजी से दांव लगाने के कारण वह अगले तीन वर्षों के दौरान आर्टिफिशल इंटेलिजेंस में एक अरब डॉलर का निवेश करेगी। कंपनी अपनी परामर्श कवायद भी मजबूत कर रही है क्योंकि आर्थिक मंदी के दौरान रणनीति मायने रखती है। विप्रो के प्रबंध निदेशक और मुख्य कार्याधिकारी थिएरी डेलापोर्ट ने मांग के माहौल, परामर्श पर ध्यान केंद्रित करने और एआई आधारित सौदों के बारे में आयुष्मान बरुआ से बातचीत की। संपादित अंशः
