- Sub: Scrutinizer Report on the Postal ballot in respect of your Company to consider and pass a Special Resolution for the Continuation of Shri S.S. Ramachandra Raja (DIN 00331491) as a Non-Executive Director of the Company after 19 August 2021 till such date he becomes liable to retire by rotation.
- I, K. Srinivasan, Practicing Chartered Accountant and Partner of M.S. Jagannathan & N. - 6. The Notice contained detailed instructions for the process of voting through postal ballots.
- 7. On the completion of the voting through postal ballot process:
 - 7.1. I scrutinized all the votes polled through the postal ballot and had entered the details of the same in a register maintained for this purpose.
