HC admits Teesta's bail plea, to hear matter on September 19

THE GUJARAT High Court Wednesday admitted a bail plea moved by Mumbai-based activist Teesta Setalvad who was arrested on charges of conspiracy and alleged fabrication of evidence in a case related to the 2002 Gujarat riots. The court will take up the matter for hearing on September 19 when she is expected to respond to the bail plea.

On July 30 refused to grant bail to Setalvad, following which she moved the HC on August 1. Setalvad, former DGP RB Sreekumar and former IPS officer Sanjiv Bhatt were named as accused in an FIR lodged on June 25, a day after the Supreme Court dismissed a petition by Zakia Jafri, wife of slain former Congress MP Alsanjiv, in a case related to the 2002 Gujarat riots. Upholding clean chit to then Gujarat chief minister Narendra Modi, the SC verdict observed that those "all those involved in such abuse of process, need to be in the dock and proceeded with in accordance with law". The Ahmedabad sessions court, while refusing bail to Setalvad, observed that Setalvad and Sreekumar "in conspiracy with others with a view to defame the then CM (Narendra Modi) and others made accusations against government that post-Godhra riots were sponsored by the (Gujarat) Government" which had allegedly "defamed the state not only in country but in world".

5 NEW PATIENTS HOSPITALISED

Surat records first death due to swine flu of this yr

SURAT REPORTED the first death due to Swine Flu this year Wednesday, when five new patients were admitted to different hospitals. As many as 32 persons have tested positive for swine flu in Surat this year. Surat did not report a single case of swine flu in 2020 and 2021 due to the Covid-19 pandemic.

According to the Surat Municipal Corporation health department, a 49-year-old woman who had been admitted in a private hospital, died during treatment Wednesday.

SMC Deputy Health Commissioner Dr. Ashish Naik said, "We have made a separate ward for swine flu patients in SMIMER and New Civil hospital. As on today, there are eight active Swine patients admitted in private and government hospitals in Surat out of which one patient is kept on a high oxygen support system and another is

Valsad: PM to inaugurate multi-specialty hospital in tribal taluka today

PRIME MINISTER Narendra Modi will virtually inaugurate a 250-bed multi-specialty hospital, built at a cost of Rs 200 crore, at the tribal-dominated Dharampur talukain Valsad district Thursday. The Shrimad Rajchandra Multipurpose Hospital that has come up on eight acres of land was started as a 40-bed facility by Shrimad Rajchandra Ashram 18 years ago. The Ashram trustees decided to expand the facility, to cater to patients from interior villages. The groundbreaking ceremony for the multi-specialty hospital was held in November 2017 and the work was completed by 2022.

"Our aim is to give the best treatment to the people... We have tie-ups with a group of Indian-origin physicians based abroad who will visit our centres... In Dharampur region people have to travel 45 kilometres to Vapi or 30 kilometres to Valsad for medical treatment," an ashram source said on condition of anonymity. Patients from interior villages are picked up and taken to hospital from where they are dropped back after treatment. The tribal-dominated Dharampur taluka has 108 villages with a population of around 245 lakh. The hospital has six hi-tech operation theatres, a paediatric ward for children, 24x7 medical and diagnostic services, an NICU for infants and sensory garden for developmental disability.

5 fishermen rescued from damaged boat

Ahmedabad: The Indian Coast Guard (ICG) has rescued five fishermen from a partially submerged boat off the Gujarat coast in Devbhumi Dwarak district, an official said on Wednesday. The operation was carried out on the intervening night of August 2 and 3 near the Okha port. "At about 12:45 am on August 3, the Indian Coast Guard District Headquarters

at Okha received information regarding uncontrolled flooding onboard Indian Fishing Boat 'Raj Ayushi' nearly 10 nautical miles off the Okha port," said a release issued by the Defence Force in Gujarat. The ICG dispatched its fast interceptor class of ship, C-413. Some vessels sailing in the vicinity of the distressed fishing boat were also alerted by the ICG to assist when needed, the release said.
