His re-appointment will be effective from August 01, 2022 to July 31, 2027 for a period of 5 (five) years.

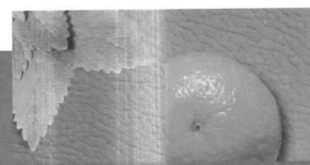

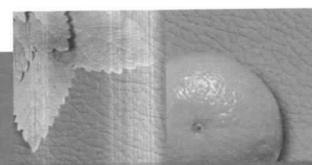
