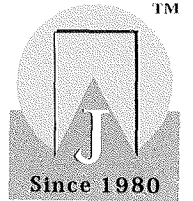

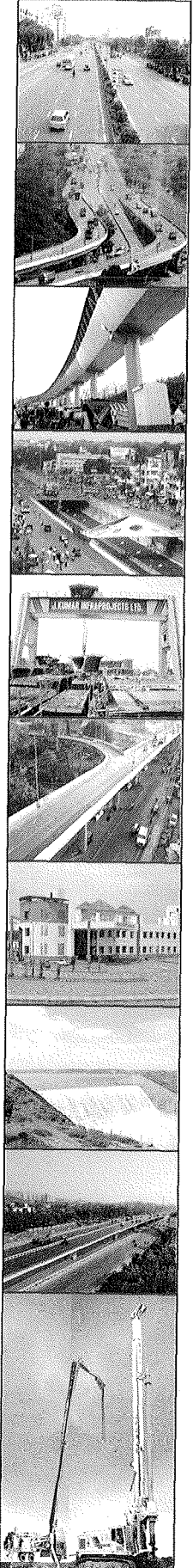

## Press Release

We are in receipt of a letter from Serious Frauds Investigation Office, Ministry of Corporate Affairs dated August 08, 2019, vide which we have been informed that the name of Our Company has been removed from the Suspect List/Confirmed List of Database of Shell Companies.

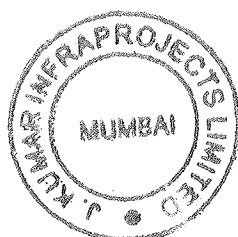
Ministry of Corporate Affairs ("MCA") had vide its letter dated June 09, 2017 forwarded to Securities and Exchange Board of India ("SEBI") a list of 331 listed companies which were suspected to be shell companies including the name of Our Company.

This list was prepared on the basis of input and reference received from Serious Fraud Investigation Office, MCA ("SFIO"). The name of our Company was included upon the inputs received from SFIO. Accordingly independent proceedings were initiated by both SEBI and SFIO for the same cause of action.

We had filed our representation before SFIO to show that we are not a shell company. On the basis of our representation and their independent examination, SFIO has now reached a conclusion that our company is not a shell company and subsequently name of our company has been removed from the Suspect List/Confirmed List of Database of shell companies.

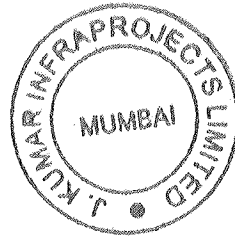
