### **SUJALA TRADING & HOLDINGS LIMITED** Report on the Audit of the Financial Statements

#### Opinion

We have audited the financial statements of **SUJALA TRADING & HOLDINGS LIMITED** ('the Company'), which comprise the Balance Sheet as at 31st March, 2023, the Statement of Profit and Loss, Statement of changes in equity and statement of cash flow for the year then ended, and a summary of the significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2023 and *profit* for the year ended on that date.

#### Basis for Opinion
