**Voters to...**

The election commission has issued detailed instructions with special focus on social distancing and access to sanitization measures for voters and polling officials. The commission has directed for mandatory sanitization of polling stations, thermal screening of voters, sanitizer at the entry/exit point of every polling station and availability of masks. Posters informing about the Covid-19 preventions would be displayed at visible locations. The last hour of voting will be for COVID-19 patients and people suspected to be suffering from the disease, additional chief electoral officer Arun Tomar said.

**Undertrial jumps...**

However, family members, relatives and friends of Sirajuddin who reached jail in sizable numbers after receiving information of his suspicious death said, "Sirajuddin can never take such a step."

They also staged a protest outside the jail. City Qazi Khaliquehman visited the jail to take stock of the situation. Jail superintendent told him that the deceased was suffering from depression. "Last night, Sirajuddin had told barrack inmates that his father had locked their house and shifted elsewhere and it would cause problems to his wife and children," Sonkar told the qazi. After post-mortem the body was handed over to the family. Meanwhile, jail superintendent informed DG, Jail, DJ, District Magistrate and SP about the incident. She also suspended four employees, including chief guard Govardhan Singh and guards Arjun Raghuvanshi, Narayan Bagri and Narayan Singh Tomar for dereliction of duty. A three-tier inquiry has also been initiated. JMFC Meenu Pachori visited the jail for judicial probe. Secondly, Bhairavgarh police along with FSL team also collected evidence. Thirdly, jail superintendent herself started departmental probe.

**SC stays...**

Advocates who appeared for Nath told court that it was prerogative of his party and not the ECI to remove his name as a star campaigner. ECI said Nath's petition against October 30 order is infructuous as the campaigning for bypolls to 28 Vidhan Sabha constituencies is over. After apex court order, Congress leader and senior advocate Vivek Tankha tweeted, "SC stayed ECI order delisting Kamal Nath as a party star campaigner."

**Trump keeps**

According to a Morning Consult poll released Monday and taken on October 22-31, Biden has a lead in Florida and Pennsylvania, the two states considered to be must-wins for Trump to secure another term. Texas, a deeply Republican state that hasn't voted for a Democratic president since 1976, is tied with the likely voters split 48.1 per cent for which candidate they are casting their ballot. According to the rolling poll, the only swing state where Trump is leading is Ohio where he holds 49.2% compared to Biden's 46.6%. Trump hinted at a rally that he might fire Dr. Anthony S. Fauci after Election Day, further heightening the tension between his administration and the nation's top infectious disease expert, even as the number of new corona cases in the US touches new highs. That had the supporters up on their feet, chanting, "Fire Fauci! Fire Fauci!" Trump listened in silence for a few moments before remarking: "Don't tell anybody, but let me wait until a little bit after the election. I appreciate the advice."

**NIA nabs Al-Qaeda conspirator who organised meetings**

The National Investigation Agency (NIA) arrested a conspirator of Al-Qaeda from West Bengal, who was generating funds and recruiting people for the banned terror organisation and also organised conventional meetings, officials said on Monday. An NIA spokesperson here said that it arrested Abdul Momin Mondal, a resident of Murshidabad district, in connection with the Al-Qaeda case of West Bengal and Kerala on Sunday. The official said that Mondal was working as a teacher in Raipur Darur Huda Islamia Madrassa in

Murshidabad and was found to be involved in a "series of conspiratorial meetings convened by the members of the Al-Qaeda module".

"He was also trying to recruit new members for the group and was raising funds for furthering its terrorist activities," the official said. The NIA official said that the residential premises of the accused were searched and digital devices were seized.

The NIA registered a case on September 11 this year pertaining to anti-national activities by a group of jihadi terrorists consisting of more than 10 members inspired by

globally proscribed terrorist group Al-Qaeda planning to carry out anti-national and terrorist activities at different locations in India including but not limited to West Bengal, Delhi and Kerala. The NIA has so far arrested 11 accused have been arrested in the case.

**NDA consolidates position in RS; Cong at lowest ever tally**

**NEW DELHI:** The ruling NDA dispensation further consolidated its position in Rajya Sabha crossing the 100-mark after 9 BJP candidates, including Union Minister Hardeep Singh Puri, were elected unopposed to the Upper House on Monday.

On the other hand, the Congress, which dominated the Upper House for a long time, is now down to 38 seats — its lowest ever tally — in the 242-member House after it lost 2 more seats to the BJP in the current elections. Of the 11 Rajya Sabha seats up for grabs, 10 from UP and 1 from Uttarakhand — 9 were won by BJP candidates, including Union Urban Development Minister Puri, taking the party's tally to 92 seats.
