Girdhar, IP registration No. IBBI/IPA-003/IP-N00048/2017-18/10396 was appointed as the Resolution Professional to manage affairs of the subsidiary company in accordance with the provision of the Code.
		On January 9, 2024 the Hon'ble NCLT Mumbai Bench, has passed an order in IA No. 1240 of 2021 in CP(IB) 2985 of 2018 and the Resolution Plan submitted by L. G. Balakrishnan and Bros Limited ("Resolution Applicant") was approved, which has become effective from the date of passing order.
		The subsidiary company has filed the requisite e-form(s) with Registrar of Companies regarding the change in Board Structure/ Management and also implemented the terms and conditions as mentioned in the NCLT Order.
		Pursuant to that the Resolution Plan has been implemented and RSAL Steel Private Limited have ceased to be a subsidiary of IMEC Services Limited and from now the Company shall not have any control over the affairs of the subsidiary company.
