<u>Subject: - Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations")</u>

Dear Sir / Madam,

Pursuant to Regulation 30 and in accordance with clause 20(b) of Para A of Part A of Schedule III the Listing Regulations read with circular dated July 13, 2023 issued by SEBI, the Company received two Compounding / Notice each dated 20th June, 2023 from Department of Labour, Government of Tamil Nadu on 4th August, 2023, seeking explanation for certain non-compliance observed, during the inspection conducted on 31st May, 2023 at the commercial establishment of the Company, under the Tamil Nadu Shops and Business Establishments Act, 1947 and Tamil Nadu Shops and Business Establishments Rules, 1948.

These notices were duly responded to the Department of Labour on 8th August, 2023. The Company received the copy of final order dated 31st August, 2023 on 29th September, 2023 levying penalty charge of INR 3,000 (Rupees Three thousand) and INR 9,000 (Rupees Nine thousand), which were paid by the Company on 29th September, 2023. The aforesaid matter was placed before the Audit Committee of the Board on 25th October, 2023. The Company missed this intimation to exchanges purely due to oversight.

The Company is filing the required disclosure under the Listing Regulations and providing the required details of the aforesaid matter in **Annexure-A**.
