Koreas stare at talks as North asks US to ease sanctions

ASSOCIATED PRESS South Korea, August 10

THE RIVAL KOREAS plan to hold high-level talks on Monday to prepare for a third summit between their leaders, as Pyongyang called on the United States to reciprocate its "goodwill measures" by easing sanctions and stopping demands that the North denuclearise first.

The plans by the Korean leaders to meet come as Washington and Pyongyang try to follow through on nuclear disarmament vows made at a US-NKorea summit in June between President Donald Trump and North Korean leader Kim Jong Un.

Chinese scholar predicts end to child birth curbs

BLOOMBERG Beijing, August 10

A CHINESE GOVERNMENT researcher called for lifting limits on the number of children a family can have, in the latest sign that policy makers are considering ending decades of restrictive birthcontrol policies.

"We need to lift restrictions on births completely," Zhang Juwei, director of the state-run Chinese Academy of Social Sciences' Institute of Population and Labor Economics, said in an interview published Friday in *China Newsweek* magazine. "It has become an irresistible trend to allow people to make their own decisions on fertility, which will be the direction for the adjustment of population policy in the future."

Bloomberg News reported in May that the country was planning to scrap birth limits as soon as this year.

In the most recent sign of growing frustration between Washington and Pyongyang, North Korea criticised senior American officials for insisting that N Korea give up its nuclear weapons first before easing sanctions. The statement didn't directly criticise Trump.

North Korea said in a statement on Thursday that "some high-level officials within the US administration" were making "desperate attempts at intensifying the international sanctions and pressure".

"We hoped that these goodwill measures would contribute to breaking down the high barrier of mistrust" between Pyongyang and Washington, the North's Foreign Ministry spokesperson said. "However, the US responded to our expectation by inciting international sanctions and pressure".

Those American officials are "going against the intention of President Trump to advance the DPRK-US relations, who is expressing gratitude to our goodwill measures for implementing the DPRK-US joint statement," it said referring to the North by its official name, the DPRK.

Washington has said sanctions will not be lifted until Pyongyang fully and finally dismantles its nuclear weapons. Experts say that North Korea does not want to denuclearise first or maybe denuclearise at all because it wants a long, drawnout process that sees external

aid shipped in in return for abandoning nuclear weapons.

Pyongyang has also stepped up its calls for an end to the Korean War, which some analysts believe is meant to be the first step in the North's effort to eventually see all 28,500 US troops leave the Korean Peninsula.

A South Korean official at the Unification Ministry, who spoke on condition of anonymity because of office rules, said the two Koreas will also discuss on Monday ways to push through tension-reducing pacts made during an earlier summit between Kim and S Korean President Moon Jae-in. Among the agreements was holding another inter-Korean summit in the fall in Pyongyang.


