Schaeffler India continues to take measures in order to fight COVID 19

- Operations shut across 4 plants in Talegaon, Maneja, Savli and Hosur respectively, including warehouses
- All branch offices and corporate office to remain shut and employees to work from home
- All measures taken for employee safety and well-being, to remain in place till further notice

Pune | 3 April, 2020 | Leading industrial and automotive supplier Schaeffler India Limited, today shared the measures that are being taken to fight the unprecedented COVID-19 situation.

In line with the government directives, Schaeffler has ensured the closure of all its plants across Talegaon, Maneja, Savli and Hosur up to April 14, 2020. This closure also includes all warehouses and branch offices across the country.

Under these extraordinary circumstances, all our non-production and management staff are working from home as per the policy already in place for their safety and well-being. During these times we will continue to provide all necessary assistance to our customers on relevant topics and required support.

The situation is being constantly reviewed by the Crisis Management Cell led by the Schaeffler India Limited management.

In the weeks preceding the shutdown, the company has implemented several measures to ensure safety and well-being of all employees, in both production and non-production areas. The company activated a slew of safety policies such as no-handshake policy, no visitors policy, ban on international and domestic travel, minimum 6 ft distance at workplaces, among others.

These policies will remain in place till further notice.
