

During the year, the company has acquired 30,12,000 equity shares of Rs. 10 per equity share comprising Rs. 301.20 lakhs of its subsidiary namely ABE (Banks) Ltd Pvt Limited. Consequently an amount of Rs. 28.11 lakhs have been written off in Financial Year 2018-19. 9. The Company has adopted Ind AS 115 Revenue from Contracts with Customers which is mandatory for operating period beginning on or after 1st April 2018. Adoption of this standard did not have any material impact on the financial result of the Company. 10. The deferred tax includes MHT credit entitlement recognized during the year aggregating to Rs. 78.30 lakhs. 11.
