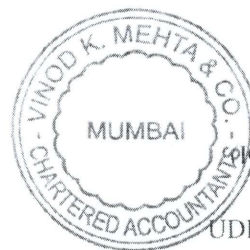

The consolidated unaudited financial results also includes the Group's share of net profit/(loss) after tax Rs. 45.39 lacs and total comprehensive income / loss of Rs. 45.50 lacs for the quarter ended as on 30th June 2021 as considered in the consolidated unaudited financial results.
