पहले कानपुर निवासी रोहन अग्रवाल और हर्षवर्धन गुप्ता से संपर्क किया। इन लोगों के साथ मिलकर बड़े पैमाने पर फ्राड करने लगा। इसी तरह मोहन के संपर्क में संयम जैन और अरमान भी आ गए। ये सभी मिलकर देश के विभिन्न शहरों से ठगों को अकाउंट उपलब्ध कराते लगे।
