We refer to your cited email, seeking clarification from the Company on the recent news appeared in the “www.business-standard.com” dated November 16, 2022 captioned “Page Industries to invest Rs 290 cr to set up two facilities in Telangana”.

In this regard, we would like to clarify that; the Company in the ordinary course of business is expanding its manufacturing facility to meet the future demand, for which we are looking for land parcel or building which suits to our requirement in various locations including in the state of Telangana. During the process, the Company officials met officials from the Government of Telangana to understand availability of land, price, location etc. However, neither definitive agreement has been entered nor formal proposal has been submitted. Hence, heading of the news item is not correct.

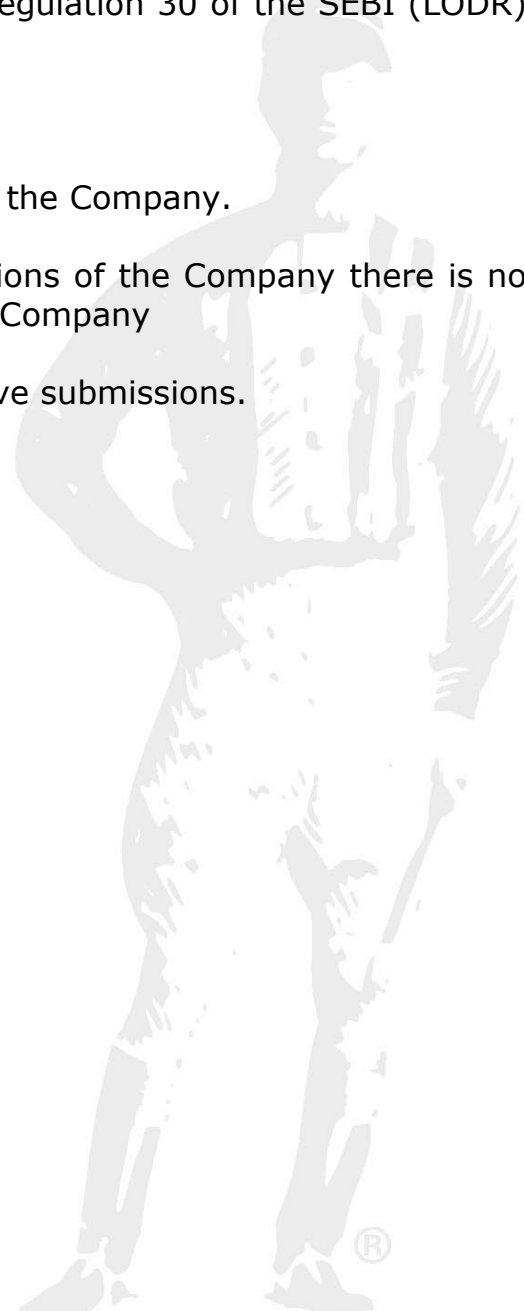
