

### IEA: India CO2 emissions to surpass 2019 levels in 2021

**FE BUREAU** New Delhi, April 21

WITHTHE EXPECTED rebound in the demand for coal to meet the rising electricity requirement, carbon dioxide (CO2) emissions in the country in 2021 will be 1.4%, or 30 million tonne (MT), higher than the levels recorded in 2019, the International Energy Agency (IEA)

said in a recent report. The expected rise in coalfired electricity generation in 2021 is likely to be three times greater than the increase in generation from renewables, the agency said, adding that "coal demand is expected to increase by almost 9%, contributing the most to rebounding demand, as electricity demand recovers".

As per the Intended Nationally Determined Contribution (INDC) under the Paris climate change COP21 accord, the country has pledged to reduce the emissions intensity of its GDP by 33% to 35% by 2030 from the 2005 level. "CO2 emissions in India are now broadly on par with emissions in the European Union at 2.35 gigatonne, although they remain two-thirds lower on a per capita basis and 60% below the global average," it noted.

Emissions had dropped in 2020 as an effect of the countrywide lockdown to control the Covid-19 and economic recovery in India in 2021 is set to push emissions almost 200 MT higher than last year.
