Sub: Announcement under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is with reference to our earlier announcements dated April 01, 2023, April 05, 2023, May 04, 2023 and May 11, 2023, we would like to draw your attention to the penalty imposed by SEBI through an adjudication order against the Company and its officers. The penalty is in connection with SEBI (Prohibition of Insider Trading) Regulations, 2015, as per SEBI Adjudication Order No. Order/VV/PSS/NK/2022-23/25473-25479 dated March 31, 2023, along with a Corrigendum order dated May 03, 2023 and intimation of payment of penalty imposed on TV Vision Limited.

In this regard we wish to inform you that, Mr. Markand Adhikari, Chairman & Managing Director of the Company, has made a payment of Rs. 26,01,000 (Rupees Twenty Six Lakhs and One Thousand Only) today i.e. July 28, 2023 through UTR No. MAHBA52023072815052337. This payment includes the penalty imposed under Section 15G of Securities and Exchange Board of India Act, 1992 ("SEBI Act") and Section 23H of Securities Contract (Regulation) Act, 1956 ("SCR Act"), along with interest, all cost, charges and expenses.

Further, additional disclosures required pursuant to SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 09, 2015, with regard to Litigation(s) /dispute(s) / regulatory action(s) with impact for the above matters is attached herewith as **Annexure I**.
