# 3 Mumbai cops to face trial for forcing minor to marry rapist

THREE MUMBAI Police officers will face criminal trial for allegedly coercing a minor gangrape victim to marry her rapist in 2013, after a special court on Wednesday allowed an application filed by the victim's father to name the policemen as accused in the case.

Special Judge Madhuri H More allowed the application and directed that summons be issued against Senior Inspector Jaywant Shinde, Inspector Vivek Shende and Constable M A Bhosle.

The application, filed through lawyer Wesley Menezes, was moved after the victim, who was 13 at the time of the incident, deposed in the court in February, narrating how she was coerced by the officers to marry the accused against her will.

The three will face trial under Prohibition of Child Marriage Act and Protection of Children from Sexual Offences Act for failure to report the commission of a sexual offence.

The prosecution has claimed that the minor was gangraped by two men inside a general store in 2012 after being administered a sedative. She was threatened that her brother and father would be killed if she spoke to anyone about the incident. In

2013, after her parents realised that she was eight months pregnant, an FIR was registered against the accused by the police.

The victim, in her deposition on February 2, 2013, alleged that she was coerced into marrying one of the two men who had raped her. She claimed that when she, her father and sister went to the police station, the duty officer, Shinde, asked her if she would be able to identify the accused. She was then led to the store where one of the accused was present. He was brought to the police station, where he allegedly confessed to the crime.

The victim claimed that the same evening, Shinde told her that she should marry the accused, as he would purchase a home for her and give her child his name.

Shinde also allegedly said that the accused would bear the expenses for her education. She added that though she refused to marry the accused and told the police that she feared for her life, she was pressured by three others, including a local politician — also named as an accused in the case — till she eventually agreed to the marriage.

Following this, the two got married but soon after, the accused absconded. He remains absconding till date. The application claimed that the other two policemen also played similar roles as Shinde.

# 'Not politicians, only defence officers should talk about military actions'

IT IS a three-room house situated below a temple of the 'Devi' — a local deity — and agricultural fields. In the verandah of the house is Savitri, whose husband Tilak Raj, a constable in CRPF, died in the terror attack in Pulwama on February 14. However, the house in the remote Jandro village in Kangra district, which was bustling with political leaders three months ago, is difficult to trace even though the election campaign is in full swing.

"Abhi tak toh koi aaya nahi prachar ke liye (Till now no one has arrived for campaigning)," says Savitri (25).

With a large population in the state, especially in the Kangra and Hamirpur belt, being that of ex-servicemen and personnel currently serving in the armed forces (up to 1 lakh), in Kangra, and in the other three Lok Sabha seats in Himachal Pradesh — Shimla (reserved), Mandi, and Hamirpur — national security is one of BJP's main poll pitches.

According to the Hamirpur-based Sainik Welfare Department, the state has 1,51,000 ex-servicemen, including pensioner widows and war widows.

Back in Jandro, while she appreciates the Balakot air strikes, Savitri shows displeasure towards the constant reminder of the Pulwama attack and the actions taken by the "Modi government" after the attack.

Savitri, now among the 946 war widows in the state, says, "Vote ke liye he toh hai ye sab halla, aur kya hai. Ye koi samadhan thodi na hai. Ye 10 log maareng, toh wahan se wo log 10 aur maareng (All the brouhaha right now is for votes. Propagating military actions is not a solution since both sides are capable of killing people)."

At Palampur, under the Kangra Lok Sabha seat, G.L. Batra, father of Kargil hero Captain Vikram Batra remembered for his "Yeh dil maange more" slogan, who had died in the 1999 Kargil War, says, "The surgical strikes and the Balakot air strikes were right steps. But, I do not appreciate the politicisation of military actions. If such things need to be spoken about then only by Army officials like the Army chief or the Defence Minister... those who are authorities on defence

must speak about military actions and not politicians."

In another Lok Sabha seat, Hamirpur, Colonel (ret'd) SKS Chambial says, "By all this chest thumping they (the BJP) are inciting the terrorists. Such speeches by the party can have serious repercussions for the country's national security, but it looks like they (the BJP) are only looking at winning the elections."

All election addresses in the state for the upcoming polls, including those by Prime Minister Narendra Modi and BJP president Amit Shah, were weaved around the surgical strikes and the Balakot air strikes.

In the Shimla (reserved) seat, the contest is between senior Congress leader Col (ret'd) Dhani Ram Shandil, and the BJP candidate Suresh Kashyap, who retired from the Indian Air Force as a sen-

# 4 more Assembly bypolls in TN, DMK may have upper hand

WITH THE second phase of bypolls for four Assembly seats in Tamil Nadu to be held on May 19, the announcement of results for 22 Assembly seats along with 38 Lok Sabha seats on May 23 will be crucial in deciding the fate of the state government as the AIADMK fears running short of majority.

AIADMK has 113 MLAs, excluding the Speaker and including three Independent MLAs who won the elections on the AIADMK symbol in 2016. The ruling dispensation fears that a sweeping victory of the DMK, as predicted by many opinion polls, would essentially help the opposition party to stake its claim. DMK has 97 MLAs, including eight from Congress and one from the Indian Union Muslim League.

Amma Makkal Munnetra Kazhagam (AMMK) leader TTV Dinakaran, who defeated the AIADMK and DMK in 2017, is an Independent MLA, and his camp claims the support of at least two or three MLAs who are officially in the AIADMK camp.

"If DMK gets 21 seats, they will have 118 MLAs, past the mark of 117 to form the government. However, results of Lok

Sabha polls will set the trend in Assembly bypolls too. We have to wait and see," a senior AIADMK leader said. He said the AIADMK government, which is surviving on a thin majority with a reduced strength of 212 in the House against the original strength of 234, will have to win a minimum of eight seats to run the government till 2021.

As campaigns are in progress for the bypolls in Sullur, Tirupparankundram, Aravakurichi and Ottapidaram (SC) seats, top AIADMK leaders, who are campaigning with maximum resources on the ground, said Sullur gives them hope while the three other seats pose a question.

Aravakurichi has a sizeable number of Gounder and Muslim voters and the rival DMK candidate here is Senthil Balaji, the former AIADMK minister who joined DMK last year and has significant influence among the Gounder community.

In Tirupparankundram which has a majority of OBC-Thevar voters, there is a tri-corner contest between AIADMK, DMK and Dinakaran's AMMK, a party with a strong influence among Thevar community.

In Ottapidaram (SC) constituency, a sizeable number of Dalit votes may go in favour of the DMK alliance.

# In ASI plan to conserve Taj: shoe covers, CNG switch

THOSE VISITING the Taj Mahal may now compulsorily have to use "shoe covers" to enter the main mausoleum to keep dust and dirt away from the iconic seventh century monument which is facing structural erosion due to pollution and alleged neglect.

The Archaeological Survey of India (ASI) has submitted a host of such measures as part of a "Site Management Plan" for conserving the Taj Mahal to the Supreme Court, in pursuance of its order

earlier this year. The plan recommends a comprehensive switch to CNG fuel in Agra, strict enforcement of vehicle pollution norms and steps to prevent fine dust that will emanate from the construction of the Metro, among other things. "A complete ban on burning of bio mass/municipal waste," it said, adding that "battery and CNG operated vehicles should be encouraged. All public transport running in the city should be CNG-based or battery-operated".

The ASI also proposed measures to encourage plantation in the city's open areas and a strict implementation of the National Building Code for construction-related activities.

The ASI's plan came in the wake of a petition highlighting damage to the monument, which attracts thousands of tourists from around the world every year, due to inadequate maintenance.

The apex court, which is monitoring the Taj's upkeep, had rebuked the ASI for its alleged failure to take appropriate steps to protect the structure. It had also observed that the white marble used in the monument had turned yellow due to air pollution.

The ASI, however, in its plan said, "to address the issue of prevention of dust and dirt from the main mausoleum and maintain cleanliness, use of shoe cover is recommended to be made mandatory."

# ટ્રેડિંગ કંપનીઓ ફીડ-ગ્રેડ મકાઈની આયાત માટે ૩૧ મે સુધી અરજી કરી શકશે

**પીટીઆઈ** જે ટીઆરક્યુ (ટેરિક્સ રેટ નવી દિલ્હી, તા. ૧૫ વાણિજ્ય મંત્રાલયે સ્ટેટ એન્ટરપ્રાઇસીઝ (એસટીઇએસ) માટે ફીડ-ગ્રેડ કોર્ન કે મકાઈની આયાત કરવા માટેની અરજીઓ રજૂ કરવાની તારીખ લંબાવીને ૩૧ મી મે સુધીની કરી આપી છે. મંત્રાલય હેઠળના ડી ડાયરેક્ટોરેટ જનરલ ઓફ ફોરેન ટ્રેડ (ડીજીએફટી) એ જણાવ્યું હતું કે આવી અરજીઓ એસટીઇએસ પાસેથી મંગાવવામાં આવી છે

જે ટીઆરક્યુ (ટેરિક્સ રેટ ક્વોટા) સ્કીમ હેઠળ ૨૦૧૯-૨૦ના નાણાકીય વર્ષ દરમિયાન ૧૫ ટકાના દરે ફીડ-ગ્રેડ મકાઈ આયાત કરવા માટેની છે. બરેબર વપરાશના આધાર પર માત્ર પોલ્ટ્રી ફાર્મ માટે જ આવી આયાતની મંજૂરી આપવામાં આવેલી છે. એસટીઇએસ એપ્રિલ સુધી અરજીઓ રજૂ કરી શકી ન હોવાથી, તેઓએ સમયમર્યાદા વધારી આપવાની માગણી કરી હતી.



તેણે જણાવ્યું છે કે આપવાની શરતે એક લાખ ટન એસટીઇએસ દ્વારા ફીડ-ગ્રેડ મકાઈની આયાત માટે અરજીઓ ફાઇલ કરવાની અંતિમ તારીખ વધારીને આ વર્ષની ૩૧ મી મે કરવામાં આવી છે. એપ્રિલમાં, ડાયરેક્ટોરેટે ૧૫ ટકાના રાહત દરે ફીડ-ગ્રેડ મકાઈની આયાત કરવાની મંજૂરી આપી હતી, જેથી દેશમાં પોલ્ટ્રી ફીડ માટે સર્જાયેલી તંગીને હળવી બનાવી શકાય. વાસ્તવિક વપરાશકારને આવી હતી.

સુધીની ફીડ-ગ્રેડ મકાઈની આયાત કરવાની મંજૂરી આપવામાં આવી છે. પોલ્ટ્રી સેક્ટર તરફથી અરજીઓ રજૂઆતો મળ્યા બાદ સરકારે આ નિર્ણય લીધો હતો, મુખ્યત્વે દુકાળ, જીવાત અને વાવેતર વિસ્તારમાં ઘટાડાના કારણે ફીડ-ગ્રેડ મકાઈની ભારે તંગી સર્જવાના કારણે આવી મકાઈની આયાત કરવાની મંજૂરી આપવા બાબતે રજૂઆતો કરવામાં આવી હતી.
