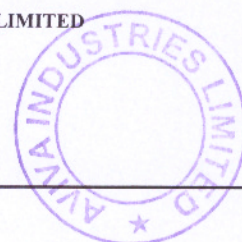

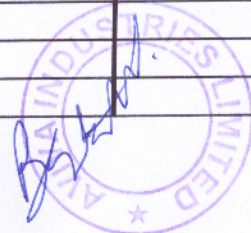

The Board of Directors are also responsible for overseeing the Company’s financial reporting process.

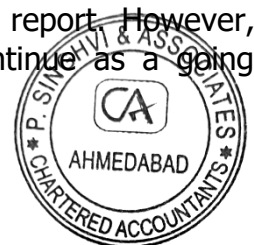


AUDITOR'S RESPONSIBILITIES FOR THE AUDIT OF THE STANDALONE IND AS FINANCIAL RESULTS
