# Centre hopes to release findings of 3 labour surveys this year

Govt to come out with Quarterly findings of surveys on Area Frame Establishment, migrant labour and domestic workers

## SURABHI

New Delhi, August 26

Paucity of data on the country's labour market remains a big challenge and the Labour Ministry hopes to unveil the findings of three employment related surveys on the unorganised sector this year to bridge a part of the gap.

These include quarterly findings of the Area Frame Establishment Survey, which is a part of the All-India Quarterly Establishment based Employment Survey (AQEES), as well as reports of the surveys on migrant labour and domestic workers.

"We hope to start releasing the reports of the Area Frame Establishment Survey from October this year. From then, it should be a quarterly exercise providing good quality, high frequency data," said a Labour Ministry source.

## 2.5 lakh establishments

In all, it would cover about 2.5 lakh establishments across the country. Till now, three reports of the Quarterly Establishment Based Survey, which is another component of the AQEES, have already been released.

The Ministry also hopes to release findings of two separate surveys on migrant labour and domestic workers later this year. "Work is on regarding both the surveys and we hope to release the findings by the end of the

year," the source said. The survey on migrant workers covers 1.5 lakh households and aims to estimate the number of such workers in the country, collect data on their household characteristics, socio-economic condition and working conditions as well as study the impact of Covid-19 on their work.

Similarly, the survey on domestic workers would estimate the number of such workers

across the country as well as assess their socio-economic conditions, wages and other related parameters.

## Social security benefits

The findings are expected to help the government as it tries to bring in social security benefits for unorganised sector workers as well as in registration of more such workers on the eShram portal.

# IRCTC withdraws tender floated to hire consultant to monetise data

## SURABHI

New Delhi, August 26

Indian Railway Catering and Tourism Corporation (IRCTC) has withdrawn the contentious tender it had floated to appoint a consultant for digital data monetisation.

"It is to further inform that due to withdrawal of Personal Data Protection Bill 2018 by the Government of India, the above referred E-tender for appointment of Consultant for Data Monetisation of Indian Railway/ IRCTC floated by IRCTC on 29 July 2022 has been withdrawn," IRCTC said in a stock exchange filing on Friday.

Previously, the Railway PSU had postponed "till further notice" a pre-bid meeting for the tender, which was scheduled on August 24.

IRCTC's tender for appointing a consultant for digital data monetisation was aimed at improving customer experience as well as

generating ₹1,000 crore in revenue.

## Privacy concerns

The consultant was expected to study customer data, including name, age, mobile number, gender, address, email ID, number of passengers, class of journey, mode of payment, login and password as well as behavioural data such as payment and booking mode, and frequency of journey.

The tender had led to considerable concerns amongst experts and passengers over privacy of their data. The Ministry of Railway had also been reviewing the project and it was expected to be withdrawn as the Data Protection Bill was taken back.

The Parliamentary Standing Committee on Communications and Information



Technology (2021-22) has also called IRCTC officials on the issue of data security and

privacy, where it was expected to ask questions on the tender.

## User base

According to its train ticketing statistics, IRCTC has a user base of 11.69 crore, of which, about 8.36 crore are active with a daily new user registration at 50,987 as on June 30, 2022.
