Subject: Results of Postal Ballot (E-voting) as per 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulation") and submission of Scrutinizer's report.

Pursuant to Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (as amended) and pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the General Circulars No.14/2020 dated April 8, 2020, No. 17/2020 dated April 13, 2020, No. 22/2020 dated June 15, 2020, No.33/2020 dated September 28, 2020, No. 39/2020 dated December 31, 2020, No.10/2021 dated 23.06.2021 and No.20/2021 dated 08.12.2021 issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars"), the approval of the members of the Company was sought for passing the Special Resolution set out in the Postal Ballot Notice dated 31st January, 2022 by means of voting through electronic means (remote e-voting) only.

Postal Ballot Notice containing the Resolution together with the statement setting out material facts concerning the Resolution set out in the Notice were sent to all the Members, whose names appeared in the Register of Members / List of Beneficiaries as on 4th February, 2022 ("cut-off date") through electronic mail and in accordance with the aforesaid MCA circulars, the Company had provided its members the facility to vote through remote electronic voting only. The remote e-voting period commenced on Tuesday, 15th February, 2022, 9:00 AM and the last date for receipt of voting through electronic means was Wednesday, 16th March, 2022 05:00 PM. The Board of Directors of the Company at its meeting held on January 31, 2022, has appointed Mr.M.D.Selvaraj, FCS of M/s. MDS & Associates, Company Secretaries, Coimbatore, as Scrutinizer to conduct the postal ballot voting through remote electronic voting means in a fair and transparent manner and for the purpose of ascertaining the requisite majority.

Accordingly, the Scrutinizer has submitted his report on postal ballot (remote e-voting) and based on his report, it is hereby declared that the Resolution set out in the Postal Ballot Notice dated 31st

January, 2022 have been duly passed by the members of the Company with requisite majority. A copy of the report of the Scrutinizer dated 16th March, 2022 is attached hereto.

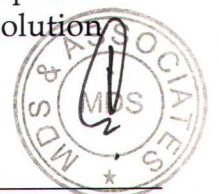

The management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules made thereunder in relation to exercising of voting rights through Postal Ballot and electronic means on the Resolution, as set out in the Postal Ballot Notice dated 31st January, 2022.

Responsibility as a Scrutinizer

My responsibility, as a Scrutinizer for the Postal Ballot through Remote E-voting process, is restricted to the preparation of the Scrutinizer's Report on the votes cast "in favour" or "against" the Resolution, as set out in Item No.1 of the Postal Ballot Notice dated 31st January, 2022, based on the reports generated from the e-voting system provided by the Link Intime India Private Limited (LI IPL), the Authorized Agency engaged by the Company for providing remote e-voting facilities.

Further in addition to the above, I submit my report as under:


- The Postal Ballot Notice dated 31st January, 2022 along with necessary statement setting out the material facts under Section 102 of the Companies Act, 2013 were sent on Monday, 14th January 2022 by Link Intime India Private Limited ("LI IPL") through electronic mail to those members whose names appeared in the Register of Members / List of Beneficiaries as on Friday, 4th February 2022 ("cut-off date") and who had registered their email ID with the Company / RTA / Depositories in compliance with the MCA Circulars. The Company has also placed the notice of the Postal Ballot on the website of the Company.
- The shareholders of the Company holding shares as on the "cut-off" date on Friday, 4th February 2022 were entitled to vote on the proposed resolution as set out in Item No. 1 of the Postal Ballot Notice.
- The remote e-voting period remained open from Tuesday, 15th February, 2022, 9:00 AM to Wednesday, 16th March, 2022, 5:00 PM (both days inclusive). During the said period, the members of the Company, holding shares in physical and / or in dematerialized form, as on the cut-off date i.e. 4th February 2022 were entitled to vote on the resolution set out in the Notice of Postal ballot through remote e-voting.



- The e-voting module of Link Intime India Private Limited ("LI IPL") was disabled on Wednesday, 16th March, 2022 at 5:00 PM and I, as the Scrutinizer, unblocked the votes cast, on Wednesday, 16th March, 2022 at 6:22 PM in the presence of Mr.A.Selten Jayaraj (the undersigned as Witness No.1) and Mr.J.Ijaz Ahamed (the undersigned as Witness No.2), who are not in employment of the Company in accordance with Rule 20(4)(xii) of the Companies (Management and Administration) Rules, 2014 (as amended).


