# PM: Defence export target for next five years to be \$5 bn

**DEEPA JAINANI** Lucknow, February 5

PRIME MINISTER NAREN-**DRA** Modi on Wednesday said India can no longer rely only on imports for its defence needs, and the target is to clock defence exports worth \$5 billion (₹35,000 cr) in the next five years.

Inaugurating the the Defence Expo 2020 in Lucknow, the Prime Minister said the new mantra is "Make in India, for India and for the world," and said this policy is being adhered to by his government to prepare a robust defence infrastructure in the country. This is the 11th edition of the event.

"India has been a major player in defence manufacturing since long, but after Independence we did not use our strength seriously as we could have. Our policies and strategies were focused on imports, resulting in the fact that India became the world's biggest arms importer. How long can the world's second-biggest population, with the secondbiggest Army and biggest democracy remain dependent only on imports? This only increases India's defence imports bill. If we continue to be

solely dependent on imports, how could we see the dream of becoming a \$5-trillion economy?"Modi said, adding that to change this situation, his government has brought about many policy reforms.

Stating that the theme of the expo, Digital Transformation of Defence, is very apt, he said the digital transformation of defence is very important not only for the present, but also for the future. "The challenges of security are as old as human life itself and with the changing times, the means of facing the challenges have also changed and become more serious. Just as life has become more technology driven, challenges of security have also become technology driven.

## Govt identifies 44 new areas for latest **CGD** auctions

**FE BUREAU** New Delhi, February 5

THE PETROLEUM AND Natural Gas Regulatory Board (PNGRB) has proposed 44 new geographical areas for the upcoming 11th round of bidding for city gas distribution (CGD). According to the new tentative list, the highest number of CGD areas will fall in Tamil Nadu (eight), to be followed by Maharashtra (seven) and Madhya Pradesh (six). At present, the CGD network covers 232 geographical areas spread over 407 districts in 27 states.

Under the ninth and 10th rounds of bidding for CGD networks, the numbers of CNG stations and domestic piped natural gas (PNG) connections are expected to increase by 8,181 and 4.2 crore, respectively, in the next 8-10 years. The present share of gas in the energy basket of the country is 6.2%, and the target is to take it to 15% by 2030.

As of September 2019, there were 1,815 CNG stations and 54.2 lakh domestic connections across the country. Currently, about 76% of the compressed natural gas (CNG) stations and 80-90% of the PNG connections are concentrated in Delhi, Gujarat and Maharashtra.

The SPV will develop the port infrastructure, including reclamation, construction of breakwater, besides establishing connectivity to the hinterland and all the business activities will be undertaken under PPP by private players. — PTI
