Kin of girl killed by crocodile get Rs 5 lakh as compensation

PRESS TRUST OF INDIA VADODARA, JULY 12

THE KIN of a 14-year-old girl killed in a crocodile attack in Gujarat's Vadodara district on July 1 were given a compensation cheque of Rs 5 lakh by local Member of Parliament Ranjan Bhatt on Tuesday, officials said.

Tulsi Naikwas dragged into Dev river in Valva village when she was washing clothes along with her sister, Deputy Conservator of Forests (Vadodara), Ravirajsinh Rathod said. On being alerted to the incident, forest and fire brigade personnel had fished out her body, he added.

In a tweet, Vadodara Lok Sabha MP Bhatt said, "Met the family members of Tulsi Naik (14), who was killed in a crocodile attack at Valva village in Waghodia taluka and paid tribute." Bhatt further tweeted she had given the family Rs 5 lakh, which was the compensation amount paid by the state forest department, and a one-month ration kit.


Sanjiv Bhatt arrested, brought to Ahmedabad

FORMER IPS officer Sanjiv Bhatt was arrested and brought to Ahmedabad by the Ahmedabad Police's Crime Branch on Tuesday evening in connection with a case filed on June 24 after the Supreme Court gave clean chit to then Gujarat chief minister Narendra Modi in the 2002 riots case.

The FIR, filed by the Ahmedabad police's Detection of Crime Branch (DCB) against former DGP RB Sreekumar and activist Teesta Setalvad accused them of submitting forged police documents in front of Nanavati Commission and misrepresentation of funds.

Bhatt was lodged at Palanpur jail in Banaskantha in connection with an ongoing narcotics case and was already convicted

with life term by a local court in a custodial death case.

The DCB lodged the case following a Supreme Court order that passed strictures against Bhatt, Setalvad and Sreekumar. The FIR quoted extensively from the apex court order.

On June 25, Setalvad was arrested from her Mumbai residence by a team of Gujarat ATS while Sreekumar was picked up from his home in Gandhinagar.

AHEAD OF Gujarat Assembly elections, the Congress appointed Raiasthan Chief Minister Ashok Gehlot as senior observer for the state Tuesday.

Additionally, TS Singhdeo, a Cabinet Minister in the Chhattisgarh government and Milind Deora, a former union minister were appointed observers for Gujarat.

In a press release by KC Venugopal, general secretary of All India Congress Committee (AICC) Tuesday, the announcement of Gehlot, Singhdeo and

A large number of those seats were credited to the man-management skills of Gehlot, who still holds sway in the political aisles of Rajasthan and Gujarat.

This time, the Congress had chosen Raghu Sharma, former health minister in the cabinet of Gehlot and his trusted lieutenant, as the AICC incharge of Gujarat. However, Sharma has been unable to stop defections and infighting in the Gujarat Congress unit with the recent exit of Hardik Patel as one of

SSG Hospital gets its first mammography machine

THE RADIOLOGY department of Vadodara's SSG Hospital Tuesday received its first mammography machine donated by a city-based foundation. The radiology department will now be equipped to test 100 patients per day.

On Tuesday, Vadodara MP Ranjan Bhatt along with other BJP leaders, inaugurated the mammography section of the radiology department, after Smile Foundation donated the machine priced at Rs 60 lakh to SSG hospital.

Trustees of the foundation, through a CSR arm of their chemical company, have also taken the responsibility for the operation and maintenance of the machine for 10 years.

Dr Chetan Mehta, head of the radiology department, said, "This digital mammography machine can produce an image in one second. It allows early detection of cancer and thereby makes it more effective to treat patients."

Medical Superintendent Dr Ranjan Aiyer said that the hospital was in dire need of a mammography machine in order to detect breast cancer in women.

Gujarat produced more than 4.29 tonnes of cumin in financial year 2021-22. AM/NS India to invest Rs 273 crore for green projects at Hazira plant

ARCELOR MITTAL Nippon Steel India (AM/NS India), a joint venture of Arcelor Mittal and Nippon Steel, is in the process of investing Rs 273 crore for zero liquid discharge and other environmental initiatives at its Hazira steel complex, stated an official release here Tuesday.

The Zero Liquid Discharge system will cover the entire Hazira plant and help AM/NS India in eliminating liquid waste by enabling reuse of the entire treated effluent with RO units. It is being set up for Rs 77 crore. The total length of the Zero

Liquid Discharge network is 14 km. The contracts related to civil works and other contracts have already been awarded, and the system is expected to be completed by March 2023. The plants covered in the first phase include Steel Making

Plants 1 and 2, Hot Strip Mill CRM-DSC, ASU, DRI-5-6, COREX 1-2, Plate mill, and INOX cryogenic Air Separation Unit (ASU). "AM/NS is committed to the

Man convicted

of stabbing

A 24-YEAR-OLD man convicted of stabbing his live-in partner was released by the Principal District and Sessions Court of the Union Territory of Daman on an appeal by the woman that she wanted to marry him and settle down.

According to the case, Dindayal Yadav, from Banda district in Uttar Pradesh and a resident of Dabhel village in Daman, was living with Chandakumari Kushwaha, from Bihar, since 2019.

The couple had a threemonth-old son and was planning to get married when on November 10, 2020, they had a quarrel following which Chandakumari left home with the child. She started staying with her maternal uncle in the same village.

On November 13, Yadav called Chandkumari and asked her to meet him near Dabhel village pond to sort out the issue. She met him and after a round of verbal altercations, Yadav took out a knife and attacked her on the throat, Chandakumari was holding their son who fell down and suffered injuries as well. Yadav escaped the spot.

Nearby shopkeepers took the injured to hospital where Chandakumari and son received treatment. Later Chandakumari lodged a complaint with Daman police station and an offence under IPC section 307 (attempt to murder) was registered against Yadav. He was arrested from Banda in UP and was sent Daman sub-jail. Police submitted a chargesheet in February 2021. After the final hearing, Principal and Sessions judge PK Sharma convicted Yadav on July 11. However, the complainant requested the judge to release him as she wanted to marry him and begin life anew.

Public prosecutor Hariom Upadhyay said, "The judge accepted the woman's request to release Yadav for starting a new life. The court treated his 19-month jail term as punishment and ordered him to be released."

With Distribution on Unsecured Perpetual Equity Instrument: (₹ 226.30 Crore)

During the Financial Years 2017-18 & 2018-19, the Company had raised funds from Adani Infra (India) Limited (AIIL) in form of Unsecured Perpetual Equity Instruments (the "Instruments") issued by the Company, which were repayable at the option of the Company. For achieving its expansion goals, the Company participates in various bids/ tenders for setting up of transmission projects through its Special Purpose Vehicles (SPVs), which are generally wholly owned subsidiaries of the Company. The Company supports these SPVs to meet equity requirement of the under-construction projects till the said projects stabilise their operation and generate revenue.
