# Bumper crop forecast: Wheat prices to soften

Open market sales to continue, purchase to be robust

SANDIP DAS New Delhi, February 15

WITH FORECAST OF a record harvest and sale of stocks in the open market by Food Corporation of India (FCI), the wheat prices are expected to soften further in the next few days, Sanjeev Chopra, secretary, department of food and public distribution, has said.

Stating that after the first eauction of wheat by FCI held earlier this month, mandi prices have fallen below ₹2,500/quintal from a high of ₹2,900/quintal, Chopra said that 'prices will be coming down further in coming days'.

The government is aiming to bring down the mandi prices of wheat to Minimum Support Price (MSP) of ₹2125/quintal announced for 2023-24 marketing season (April-June) in the next couple of weeks. On the agriculture ministry's estimate of a record wheat harvest of 112.18 million tonne (mt) for the 2022-

23 crop year (July-June), Chopra said it would boost the government's procurement drive for next the marketing season which begins on April 1.

The food ministry has called a meeting on March 1 of state ministers for setting a target for wheat procurement for 2023-24 marketing season. While bulk buyers and traders have purchased 0.92 mt of wheat from FCI in the first e-auction held by FCI at the beginning of the month. The second e-auction for selling 1.5 mt of wheat was held on Wednesday.

# West Bengal budget for FY24 focuses on infra, logistics

States' own tax revenue seen to grow by 11.4% in FY24

THE WEST BENGAL government on Wednesday presented a Budget for 2023-24, envisaging total expenditure of ₹3.1 trillion, up 8% from the revised estimate of ₹2.87 trillion in the current financial year. The Budget's thrust was on support to farmers, an ailing tea sector, and

also aimed to harness the state's potential as a logistics hub, besides spurring budding entrepreneurs.Finance minister Chandrima Bhattacharya said: "In spite of severe impact of Covid -19 pandemic and vari-

ous natural calamities in the last two years, our state has maintained a steady growth. While the Indian economy is expected to grow at 6.95% in the current financial year (2022-23), West Bengal economy is expected to growatahigherrate of 8.41% in the same period."

The state's total revenue receipts, including own tax receipts and transfers from the Centre, re estimated to grow by 9.7% to ₹2.14 trillion in 2023-24 from ₹1.95 trillion (RE) in 2022-23. Own tax revenue is seen to grow by 11.4% to ₹88,595 crore in 2023-24.

The minister said an upcoming West Bengal Logistics Policy 2023 will leverage the state's strategic position at the cross-roads of South Asiato create a global logistics hub."It will streamline the sector and help Bengal to secure a strategic position in the global supply chain," Bhattacharya said. - With PTI inputs

## Seafood exports to hit \$14 billion by 2025: Govt

New Delhi, February 15

**FE BUREAU** 

**INDIA IS AIMING** to double its seafood exports to \$14 billion by 2025 from the FY22 level, Union minister of state for commerce and industry Anupriya Patel said in Kolkata. The country exported 1.36

million tonne (MT) of seafoods during 2021-22, earning an all-time record of \$7.76 billion. "In two years from now, we plan to achieve a target of \$14 billion," she said after inaugurating the 23rd edition of India International Seafood Show

Noting that India is already among the world's top five seafood-exporting countries, the minister said 17% of the country's agricultural exports comprises fish and allied products. "We are the world's third-largest fish producer, second-largest aquaculture producer and fourth-largest seafood exporter," she pointed out at the start of the three-day event being organised by the Marine Products Export Development Authority (MPEDA) in association with the Seafood Exporters Association of India (SEAI).

The biennial showpiece event in the marine sector is being held amid the government's attempt to regain buoyancy in seafood exports in the post-pandemic phase.

Noting duty concessions on the import of vital shrimp/fish feed ingredients announced in the Union Budget 2023-24, Patel said he government's measures towards protection of the interest of the country's aqua farmers and the sector as a whole. "We slashed the import duty from 15% to 5% for fish meal and vitamin premixes, whereas the duty has been halved to 15% for fish lipid oil and algal prime," she said.


