Dear Sir/Madam,

In reference to SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we hereby submit the information of continuing litigations in terms of revised materiality threshold as determined as per above circular.

The Company has identified 4 (Four) litigation matter continuing before relevant authorities/ courts and pertaining to claims / demand against the Company wherein the amount involved in such cases may be considered material as per revised criteria in SEBI notification dated 13th July, 2023. The total amount involved is Rs. 13.06 Crore. Similarly, 12 (Twelve) material litigation matters were initiated by the Company pertaining to claims/refunds in favour of the Company amounting to Rs. 53.57 Crore. All these litigations have been treated/accounted for as per relevant Ind- AS and all of them are in ordinary course of business of the Company and pertaining to issues related to Income Tax, Customs, Power, Customers Contracts etc., which are sub-judice before relevant authorities/ courts etc.
