

Further to our letter SICAL:SD:2021 dated 16th August, 2021, we wish to inform you that pursuant to Regulation 33 of the SEBI [LODR] Regulations, 2015, the unaudited financial results for the quarter ended 30th June, 2021 had to be submitted on or before 14th August, 2021 and as was informed to the Exchanges vide our letters dated 27th June, 2021, 04th August, 2021 and 16th August, 2021, the Company could publish its audited financial results for the quarter and year ended on 31st March, 2021 on 12th August, 2021 duly completing the audit process. Under the circumstances, the Company has now taken up the limited review process for the quarter ended 30th June, 2021 for the Company and its subsidiaries and is still in progress. The delay as has been explained earlier was due to the second wave of COVID19 pandemic resulting in COMPLETE LOCKDOWN in the State of Tamilnadu during the months of May and June and also the CIRP was initiated by the Honble NCLT, Chennai Bench effective 10th March, 2021 appointing Interim Resolution Professional and on 02nd June, 2021 appointing the Resolution Professional. Under the circumstances we wish to inform you that we had already submitted our communication stating that there will be a delay in submitting the unaudited financial results for the quarter ended 30th June, 2021 and had sought an extension of time for submitting the results until 06th September, 2021. The Company has put in its best efforts and based on the current circumstances, it is observed that the unaudited financial results for the quarter ended 30th June, 2021 can be taken up for approval by the RP during the 3rd week of September, 2021 viz on or before 24th September, 2021]. Accordingly we have also attached a communication as has been submitted to SEBI in this regard.
