

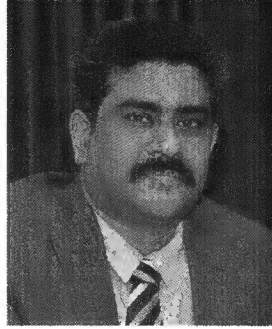

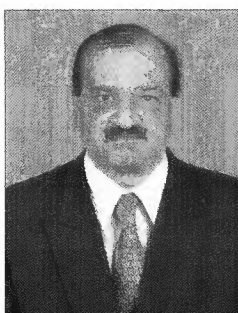
Support Group and later for MSME lending also. From May 2017 he has been heading the Mangaluru Region.

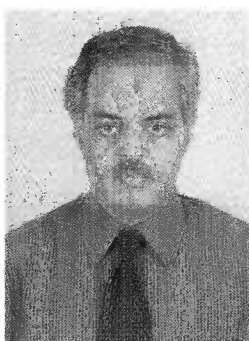
On promotion as Deputy General Manager, he will be heading the HO - Treasury & Accounts Department at Mangaluru.
