With reference to the above, I would like to inform that at present, I, Ankit Agarwal am the Promoter of the Company. On February 5, 2022, I had given a request for reclassifying me from Promoter of the Company to Public, in compliance with the Regulation 31A SEBI LODR Regulations. I had, thereafter revoked the said letter on April 20, 2022.

As on date I hold 3,36,200 (Three Lakh Thirty Six Thousand Two Hundred Only) equity shares aggregating of 4.79 (four point seven nine) percent of the paid up equity share capital of the Company.

I am no longer interested in having control over the affairs of the Company and deem it prudent in the best interest of the Company to let the Company be a purely professionally managed company. In light of this, you are requested to reclassify me as a public shareholder of the Company, in compliance with applicable regulatory provisions.

Further, in accordance with the Regulation 3IA of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI LODR Regulations, 2015), I hereby undertake and confirm as under:

- 1. I along with persons related to me together:
 - do not hold more than ten percent of the total voting rights in the company;
 - ii. do not exercise control over the affairs of the company, directly or indirectly;
 - iii. do not have any special rights with respect to the company through formal or informal arrangements including through any shareholder agreements;

I further understand that in the event I fail to comply with the conditions mentioned under point 1, 2 and 3 above, failing which I shall be automatically be reclassified as Promoter of the Company.
